Cage Club Registration/Participation Policies

- Wisconsin Rapids Cage Club eligibility rules generally require players to be able to demonstrate enrollment at a Wisconsin Rapids Public School District (WRPS) school or to demonstrate residency within the WRPS boundaries, if attending a non-WRPS school. The ultimate decision on whether a player is eligible to play for Wisconsin Rapids Cage Club will be determined in the sole discretion of Wisconsin Rapids Cage Club's board/directors.
- Wisconsin Rapids Cage Club will work in conjunction with the Wisconsin Rapids Public School District to determine eligibility of each player as well as compliance with the Player Code of Conduct.
- Wisconsin Rapids Cage Club, governed by its board/directors, reserves the right to restrict participation in its programs for any non-discriminatory reason.
- Wisconsin Rapids Cage Club reserves the right to remove any player, parent, or coach from participation in its programs for a violation of any Code of Conduct, such violation to be determined in the sole discretion of Wisconsin Rapids Cage Club's board/directors.
- Players who do not attend school on the day of a practice due to illness should not attend practice on that day.
- Wisconsin Rapids Cage Club reserves the right, at its sole discretion, to determine whether refunds for registration fees and/or uniform fees will be issued.
- **Medical treatment authorization.** By registering, parents/guardians authorize Wisconsin Rapids Cage Club coaches and staff to seek emergency medical treatment for their player in the event a parent/guardian cannot be reached, including at away tournaments.
- **Financial responsibility.** Registration and concession fees must be paid in full before a player will be permitted to practice, receive a uniform, or participate in games or tournaments.
- **Refund/withdrawal deadline.** Refund requests must be submitted in writing to the Wisconsin Rapids Cage Club board by January 1st of the active season. No refunds will be issued for withdrawals after this date, except at the sole discretion of the board.
- **Uniform ownership and return.** Uniforms remain the property of Wisconsin Rapids Cage Club unless otherwise stated. Players are responsible for the care of their uniform, and any lost or damaged uniform may result in a replacement fee.
- **Volunteer commitment.** Families are required to fulfill the number of volunteer hours per season set by the Volunteer Committee, including support at home tournaments and fundraising events. Failure to meet this commitment may result in a fee or other consequence at the discretion of the board.
- **Photo/video release.** By registering, parents/guardians grant Wisconsin Rapids Cage Club permission to use photos or video of their player for the program's website, social media, and other promotional materials.
- **Weather/schedule changes.** Any changes to practices, games, or tournaments due to weather or other unforeseen circumstances will be communicated through the PlayMetrics app. It is the family's responsibility to stay informed of schedule updates.
- **Background checks.** All Wisconsin Rapids Cage Club coaches and volunteers working directly with players undergo a background check prior to participation.
- **Transportation to tournaments.** Families are responsible for transportation to and from all tournaments and away games unless alternate arrangements are communicated in advance by the coaching staff.
