



TERMS OF SERVICE

1. INTRODUCTION

Welcome to Protect Us Kids Foundation ("PUK," "we," "us," or "our"). These Terms of Service ("Terms") govern your access to and use of our website (www.protect-us-kids.org), services, programs, and resources (collectively, the "Services").

By accessing or using our Services, you agree to be bound by these Terms and our Privacy Policy. If you do not agree to these Terms, please do not use our Services.

PUK is a nonprofit 501(c)(3) organization dedicated to protecting children and youth worldwide from cyber-related crimes, with a focus on underserved and marginalized communities.

2. WHO MAY USE OUR SERVICES

- **Adults:** Individuals 18 years or older may use our Services for educational, advocacy, and support purposes.
- **Minors:** Individuals under 18 may use our Services with parental or guardian consent and supervision. We provide child-safe resources designed specifically for young people.
- **Organizations:** Schools, community groups, nonprofits, and other organizations may use our Services in accordance with these Terms and applicable partnership agreements.
- **Professionals:** Child protection professionals, educators, law enforcement, and others working to protect children may access specialized resources.

3. ACCEPTABLE USE

You agree to use our Services only for lawful purposes and in ways that do not infringe the rights of others or restrict their use and enjoyment of the Services.

You agree NOT to:

- Use the Services to harm, threaten, or harass any individual, especially children
- Upload, post, or transmit any content that is illegal, harmful, threatening, abusive, defamatory, or obscene
- Upload or share child sexual abuse material (CSAM) or any exploitative content

- Use AI tools to generate child sexual abuse material (CSAM) or any exploitative content involving minors, whether real or synthetic
- Use the Services for any commercial purpose without our prior written consent

4. USER ACCOUNTS

Some Services may require you to create an account. When you create an account:

- You must provide accurate, complete, and current information
- You are responsible for maintaining the confidentiality of your account credentials
- You are responsible for all activities that occur under your account
- You must notify us immediately of any unauthorized use of your account
- We reserve the right to suspend or terminate accounts that violate these Terms

5. CONTENT AND INTELLECTUAL PROPERTY

Our Content: All content on our Services, including text, graphics, logos, images, videos, and software, is owned by PUK or our licensors and is protected by copyright, trademark, and other intellectual property laws.

Your Content: When you submit, post, or share content through our Services ("User Content"), you grant PUK a non-exclusive, royalty-free, worldwide license to use, reproduce, modify, and display that content solely for purposes related to our mission.

You represent and warrant that:

- You own or have the necessary rights to share your User Content

- Contains or depicts child sexual abuse material (CSAM)
- Exploits, harms, or endangers children in any way
- Violates privacy rights or shares personal information of children without proper consent
- Infringes intellectual property rights
- Contains viruses, malware, or other harmful code
- Is hateful, discriminatory, or promotes violence
- Is AI-generated synthetic media (deepfakes) depicting real individuals without their consent
- Is AI-generated content designed to exploit, groom, or endanger children, whether depicting real or fictitious minors
- Contains AI-generated content that falsely represents PUK's positions, endorsements, or communications
- Is misleading or fraudulent

We reserve the right to remove any content that violates these Terms and to report illegal content to appropriate authorities.

7. THIRD-PARTY LINKS AND SERVICES

Our Services may contain links to third-party websites, services, or resources. These links are provided for convenience only.

PUK does not control or endorse third-party sites and is not responsible for their content, privacy practices, or terms of service.

Your interactions with third-party sites are solely between you and the third party. We encourage you to review their terms and privacy policies.

PUK is a 501(c)(3) tax-exempt organization. Donations to PUK may be tax-deductible to the extent permitted by law.

We reserve the right to refuse participation or remove participants who violate our policies or engage in conduct that endangers others.

- PUK does not use AI for automated decision-making that produces legal or similarly significant effects on individuals without human oversight
- PUK does not use AI tools that process children's data unless those tools have undergone a documented child data protection review
- PUK will disclose in its Privacy Policy when AI tools are used in service delivery in ways that process personal data

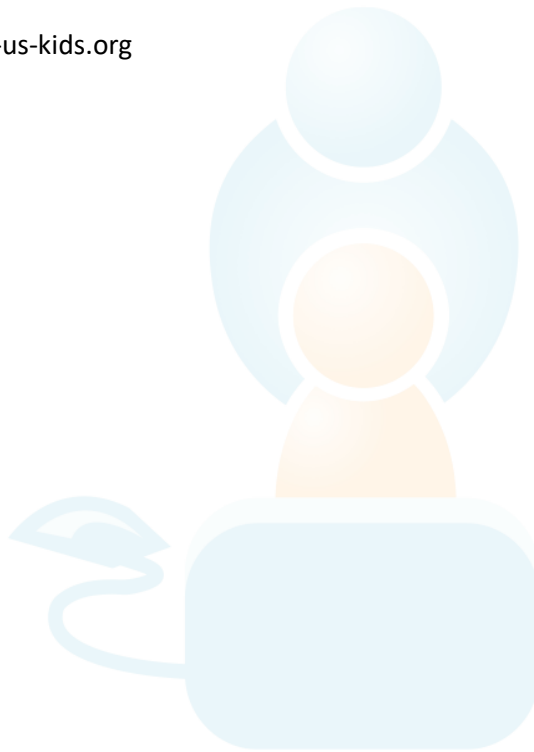
