Approvals

Minutes

General Discussion

Rectory occupancy and use

The major topic of discussion related to future use of the two parishes' rectories. St. John the Baptist's is currently rented to Spiritus, which has five women living there. However, diocesan guidelines no longer allow such rental of residential facilities. Spiritus is grandfathered in, but their pending departure in a year or two puts the future use of the space in question. It has been inspected by Miron and found to be in very good condition, suitable for remodeling, perhaps as a parish center, residence for the pastor, or other space. St. John would welcome St. Mary's investment and participation in its redevelopment, if a common need is identified.

St. Mary's rectory is vastly oversized for its current use, which is providing residential space for Fr. Settle and Fr. Jude Egbuna. St. Mary has not systematically considered its renovation or future use since Fr. Lightner and Miron floated a parish-center-with-apartment style renovation several years ago. There may be concerns about the plumbing and electrical systems, and the on-going costs of heating and cooling the structure are recognized. Some options considered over time have included inviting the priests of the five parishes to live in community, providing rooms for male Spiritus missionaries, using the ground floor as parish-office space in case of further school expansion, conversion to a small residence with additional parking, etc.

Relevant data presented included that, per Miron, new construction is roughly four times as expensive as renovation of existing structures, and that the City of Menasha will likely seek to impose their requirement of providing one space of off-street parking for every four people who can be accommodated in the church pews if any new building projects are undertaken.

Parish fundraisers

Because the scrip budget was increased to balance next year's budget, we are currently above last year's sales, but are down a percentage point in revenue, and therefore behind budget. We sold out of Kwik Trip at 10% return and had to replace with some 5% cards; we have also sold a lot of Amazon, which only returns 1½%.

The number of purchasers has not increased hugely, but core purchasers are buying more. (We had 155 families out of ≈1,000 participating in July, a good increase from 120 last year.) Lauren is messaging effectively and in varied fashion, but we can always use more ideas.

Scrip provides us \$50K of income without donations.

The historic objection because of credit-card points is obsolete because credit-card purchases of scrip are available online. We carry more inventory than other parishes—others have a two-week wait for orders.

The bottom line is we're doing better than we have been recently, but are still under the new, higher budgetary target.

In the near future, Steve will ask for approval for next advance bulk purchase of Kwik Trip.
