Guest Services: The Museum creates an active, involved and social environment for car enthusiasts. It provides engaging and entertaining exhibitions for a broad spectrum of the community. To enhance the visitor experience, the Museum offers racing simulators and slot car driving. Attendance in 2024 = 90,000.

4b (Code:) (Expenses \$ 508,550 including grants of \$ 0) (Revenue \$ 15,820)

Collection and Exhibitions: The Museum is dedicated to secure and interpret the extensive LeMay car collection as well as to acquire, preserve and interpret additional mobility collections. There are approximately 260 cars in the collection. The Museum breaks the traditional design of static displays of cars by rotating exhibitions from its vast collection and showcasing auto manufacturers' achievements and future directions in design, technology and product development. The Museum opened 2 exhibits in 2024.

4c (Code:) (Expenses \$ 273,080 including grants of \$ 300) (Revenue \$ 261,153)

Education: An interactive center for all "students" of automotive history, restoration and preservation. During 2024, the Museum continued to increase its number of education activities, such as hosting 3,000 third graders to the Museum. It has established itself as a valuable resource for the Boy Scouts, Girl Scouts and homeschooling communities and positioned itself as a central hub for STEM/STEAM learning.

The collection has been acquired through purchases and contributions since the Museum's inception. The Museum has adopted a policy of not capitalizing the collection in its financial statements. Accordingly, no collection items are recognized as assets, whether they are purchased or received as a donation. Purchases of collection items reduce net assets in the period when purchased. Proceeds from sales or insurance recoveries are recorded as increases in net assets when received. It is the policy of the Museum that proceeds from the sale of any collection items are to be used to purchase additional collection items.

The cars are used in the interactive educational center for interpreting automotive history and demonstrating restoration and preservation.
