Method of Use

Shake the bottle before use.

Squeeze the bulb of the teat pipette and draw up the liquid to the 0.25 ml mark and administer to the baby. Avoid contact of the dropper with the baby's mouth or food to prevent contamination of the bottle contents.

Do not exceed the recommended use.

Keep out of the reach and sight of children.

Storage

Store in a cool and dark place, protect from light. Store in the original container. Do not store above 25°C. Do not freeze.
