MEMBERSHIP AGREEMENT

This Membership Agreement (“**Agreement**”) is entered into as of the date approved by The Bridges on the Membership Application by and between the Member (defined below) and Remington’s Operating Partners, LLC, a Colorado limited liability company dba The Bridges Golf and Country Club (“**The Bridges**”). Members desire the opportunity to enjoy The Bridges’ facilities on a regular basis and obtain certain privileges associated with being identified as a member of The Bridges on the terms and conditions set forth herein.

- 1. Member.** For purposes of this agreement, “**Member**” shall mean the Applicant, Spouse, and Qualifying Children identified on the Membership Application. For purposes of this Agreement, “**Spouse**” means the person legally married to, in a civil union with, or in a registered domestic partnership with the Applicant. “**Qualifying Children**” means an unmarried child of an Applicant or Spouse under the age of 23 and enrolled in an accredited school.
- 2. Membership; Term.** Unless otherwise identified on the Membership Application, Member’s privileges will begin on the date this Agreement is approved by The Bridges and remain in effect for 12 months (“**Initial Term**”). If the Member wishes to terminate this Agreement before the expiration of the Initial Term, the Member will pay The Bridges the Monthly Dues owed for the remainder of the Initial Term. At the end of the Initial Term, this Agreement shall automatically continue on a month-to-month basis (each, a “**Renewal Term**,” and together with the Initial Term, the “**Term**”) until terminated by either the Member or The Bridges upon 30 days’ written notice to the other. If the Member wishes to terminate this Agreement after the Initial Term, neither the Initiation Fee nor any Monthly Dues shall be prorated. This Agreement may be terminated by The Bridges if a Member breaches this Agreement or violates any rules, regulations, policies, or procedures of The Bridges, as they may be amended from time to time, and any amounts paid by the Member to The Bridges shall be non-refundable. Payment of Monthly Dues does not give a Member any right, interest or ownership in The Bridges. This Agreement shall automatically terminate upon the death of Member.
- 3. Membership Types, Member Privileges, Membership Dues.** For the duration of the Term, Member will receive certain benefits, which may vary and are dependent upon the Membership Type selected in the Membership Application. Collectively, the benefits associated with a Membership Type are referred to as “**Member Privileges**.” The initial Membership Types and Member Privileges are described on the attached Membership Information Sheet. The Bridges reserves the right to modify Membership Types, Member Privileges, Initiation Fees, and Monthly Dues at any time at its own discretion by providing 30 days’ written notice to Member. Eligibility for Membership Type is determined by the age of the eldest Applicant or Spouse, where applicable.
- 4. Monthly Dues.** The Member shall pay the Monthly Dues set forth on the Membership Application, (as may be modified from time to time by The Bridges upon 30 days’ prior written notice), on a monthly basis upon invoice by The Bridges.
- 5. Initiation Fee and Other Fees.** The Member must pay the one-time non-refundable Initiation Fee set forth on the Membership Application upon acceptance of this Agreement by The Bridges. Optional amenities that are made available to Members may incur additional fees as set forth on the Membership Application and as may be modified from time to time by The Bridges upon 30 days’ prior written notice. All fees are non-refundable.
- 6. Food and Beverage Minimum.** All Membership Types are subject to a mandatory quarterly food and beverage minimum spend as determined by The Bridges on an annual basis (the “**Minimum**”). If a Member does not spend the Minimum in a given quarter, the Member shall pay the balance with the Member’s next monthly invoice.
- 7. Payment of Membership Account.** All dues, fees, food, beverage, merchandise, services, and other amounts due to The Bridges by a Member will be maintained by The Bridges in the Member’s account billed monthly. Member agrees to pay all amounts owed by the Member, the Member’s Spouse, Qualifying Children, and their respective guests when due. Past due bills will accrue a late fee each month in an amount equal to a minimum late fee established by The Bridges from time to time or interest at the maximum, non-usurious rate permitted by law from the date of the statement until paid in full. In the event of non-payment for sixty (60) consecutive days, the Member Privileges will be automatically suspended until payment is made in full. Member further agrees to pay all reasonable attorneys’ fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts. **There is no sales tax charged on Monthly Dues.**



8. Compliance. NO MEMBER SHALL EVER IMPINGE ON ANOTHER MEMBER'S ENJOYMENT OF THE BRIDGES' FACILITIES.

Members agree to abide by The Bridges' general rules, regulations, policies and procedures set forth herein and as may be published by The Bridges from time to time. The Bridges expects Members to assist The Bridges in keeping its facilities safe, clean, and fun for everyone. Accordingly, Members agree to observe, and to cause their guests to observe, all federal, state and local laws at all times. **No alcohol may be brought onto The Bridges premises.** The only alcohol to be consumed on site is alcohol purchased on site. Member shall promptly reimburse The Bridges for any damage to The Bridges' property caused by a Member or their guest. Members are responsible for damage caused by their guests. The Bridges reserves the right to suspend the Member Privileges or terminate this Agreement if the Member uses excessive foul language, illegal substances or exhibits aggressive or violent behavior.

9. Use of Golf Carts. As a rule, golf carts are allowed on the fairways; however, inclement weather or other conditions may invoke further cart restrictions. The Bridges staff will notify Members of any temporary restrictions, but players are expected to refrain from driving golf carts where it may damage the golf course. Members are required to have a full valid driver's license to operate a golf cart. Member-owned golf carts are allowed with approval and can be stored on The Bridges property based on storage availability; however, The Bridges assumes no responsibility for the security of any Member-owned golf carts and is not responsible for any loss or damage to Member-owned golf carts. Members who own a golf cart are subject to an annual trail fee established by The Bridges. No more than two carts per foursome are allowed unless authorized by The Bridges staff. No more than two riders and two golf bags are allowed per cart. Rental of golf carts is subject to a per-usage fee established by The Bridges.

10. Early Termination or Suspension of Member Privileges. Notwithstanding anything to the contrary in this Agreement, in the event that Member (a) becomes disabled, sick or injured for a period exceeding thirty (30) continuous calendar days; (b) is activated for military service; or (c) is relocated for business more than (i) fifty (50) miles from The Bridges and (ii) more than fifty (50) miles from Member's address set forth on the Membership Application, The Bridges may, in its discretion, either suspend the Member Privileges until the Member returns or terminate the Member's membership. In the event of **disability, injury or illness**, Member must provide a doctor's note to The Bridges. In the event of **military service**, Member must provide a copy of military orders from issuing authority. In the event of **relocation**, Member must provide a copy of a utility bill or other correspondence to demonstrate new domicile. If the Member requests termination of this Agreement for one of the above reasons, The Bridges will terminate the Membership at the end of the following month. In the event of suspension, The Bridges will not issue any refunds but will suspend Monthly Dues during the suspension period. The Bridges shall not be obligated to terminate or suspend a Member's membership. Decisions regarding early termination or suspension of membership will be in the sole and absolute discretion of The Bridges.

11. No Warranty. The Bridges provides the Member Privileges on "as is" basis, without warranty or guarantee of any kind, either express or implied, including, but not limited to, the implied warranties or conditions of merchantability or fitness for a particular purpose.

12. Limited Liability. In no event shall The Bridges, its members, managers, affiliates, or investors, or their respective members, managers, directors, officers, employees, contractors, representatives or agents ("**The Bridges Parties**") be liable for loss of any kind or for indirect, special or consequential damages of any kind, even if The Bridges Parties had been advised of the possibility of such damage. The Bridges disclaims any and all loss or liability resulting from, but not limited to: acts of God, unauthorized use or misuse of your account information, errors, omissions or misstatements in any information or Member Privileges provided under this Agreement or Member's inability to use Member Privileges. The Bridges Parties' entire liability arising out of this Agreement, and Member's exclusive remedy with respect to any matter arising out of this Agreement, is limited to the actual amount paid in Monthly Dues.

13. Indemnification. Member shall indemnify The Bridges Parties and protect and hold The Bridges Parties harmless from and against any and all claims, liabilities, losses, costs, damages, expenses, including consultants and attorney's fees, court costs, demands, causes of action and/or judgments directly or indirectly arising out of or related to this Agreement or Member's or Member's guests' use of the Member Privileges, including, without limitation, the consumption of alcohol.

14. Notice. Any notice required or permitted by this Agreement shall be in writing and shall be deemed sufficient upon receipt, when delivered personally or by courier, overnight delivery service, confirmed email, or forty-eight (48) hours after being deposited in the regular mail as certified or registered mail with postage prepaid. Any notices to The Bridges



shall be delivered to The Bridges at the following address: The Bridges Golf and Country Club, 2500 Bridges Dr. Montrose, CO 81401 ; and/or email address: gbray@thebridgesgcc.com, or any other address provided by The Bridges to Member for this purpose from time to time. Any notices to Member shall be delivered to the address and/or email address set forth in the Membership Application.

Member Privileges

The Member Privileges are as follows:

- A. **Resident and Non-Resident Golf Memberships.** (Age 50 and above) All Golf Memberships are subject to monthly dues and provide all of the following Member Privileges at The Bridges Country Club for Members, their spouses and dependents under the age of 23 and in an accredited School: Complimentary greens fees and practice facility access, Access to all dining areas and member recreation areas, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of discounted/specified guest fees. (Resident is defined as living inside the Bridges Community, Non-resident is outside the Bridges Community and within 50 miles of the Bridges.)
- B. **Junior Golf Memberships.** Junior Golf Memberships are age 49 and below, and subject to monthly dues and provide all of the following Member Privileges at The Bridges Country Club for Members, their spouses and dependents under the age of 23 and in an accredited School: Complimentary greens fees and practice facility access, Access to all dining areas and member recreation areas, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of discounted/specified guest fees.
- C. **Super Junior Golf Memberships.** Super Junior Golf Memberships are age 35 and below, and subject to monthly dues and provide all of the following Member Privileges at The Bridges Country Club for Members, their spouses and dependents under the age of 23 and in an accredited School: Complimentary greens fees and practice facility access, Access to all dining areas and member recreation areas, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of discounted/specified guest fees.
- D. **Corporate Golf Memberships.** (Minimum of 4 and up to 6 total Memberships) Corporate Golf Memberships are subject to dues and provide all of the following Member Privileges at The Bridges Country Club for Members, their spouses and dependents under the age of 23 and in an accredited School: Complimentary greens fees and practice facility access, Access to all dining areas and member recreation areas, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of discounted/specified guest fees. All Dues must be paid by the corporate entity as a lump sum payment. Dues may be paid annually on the anniversary date of membership inception or paid monthly.
- E. **Western Slope Golf Membership.** A “Western Slope Golf Membership” is subject to monthly dues and provides all of the following Member Privileges at The Bridges Country Club for Members, their spouses, and dependents under the age of 23 and in an accredited School, all of whom must not own/lease a residence within 50 miles of THE BRIDGES: Complimentary greens fees and practice facility access, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of discounted/specified guest fees. (This member category may be restructured or discontinued after the initial term of execution/signing)
- F. **National Golf Memberships.** A “National Golf Membership” is subject to monthly dues and provides all of the following Member Privileges at The Bridges Country Club for Members, their spouses, and dependents under the age of 23 and in an accredited School, all of whom must not own/lease a residence within 150 miles from THE BRIDGES: Complimentary greens fees, access to dining facility discounts, invitations to Member tournaments and events, ability to invite accompanied guests with payment of



discounted/specified guest fees. (This member category may be restructured or discontinued after the initial term of execution/signing)

- G. **Resident and Non-Resident Social Membership.** A “Social Membership” is subject to monthly dues and provides all the following Member Privileges at The Bridges Country Club for Members, their spouses, and dependents under the age of 23 and in an accredited School: Access to all dining areas and member recreation areas, dining facility discounts, ability to invite accompanied guests with payment of specified guest fees. A Social Member has the option to play golf 6 (Six) times annually with the payment of discounted/specified fees. (Resident is defined as living inside the Bridges Community, Non-resident is outside of the Bridges Community and within 50 miles of the Bridges.)
- H. **Youth Golf Membership.** The Youth Golf Member is between 12 to 22 years of age. He or she is entitled to golf course facilities only, which includes the golf course, short game range, putting greens, and driving range. The Youth Golf Member may rent a golf cart only if they have a valid full driver’s license. This membership class is subject to monthly dues and is strictly for the Youth Golf Member. It does not allow any other member of the family access to club facilities or social activities. Note: Youth Member that is over the age of 21 is permitted in the Member dining and recreation areas.

NOTE: Accompanied Guests of Golf Members –

Any one Guest is allowed six (6) rounds total per calendar year at the discounted accompanied guest rate. The accompanied guest discount rate is determined at the sole discretion of The Bridges and may vary from time to time.

Rules for a Valid Hole In One

A Hole In One is considered valid:

- If made during a round of at least nine holes, except that a hole in one made during a competition match should be acceptable even if the match ends before the stipulated 9 hole round is completed.
- If the player is playing one ball; a hole in one made in a practice round in which the player is playing two or more balls will not be acceptable.
- If attested by someone acceptable to the Committee. (Minimum of one acceptable witness)
- If made during a stipulated round shortened by an event out of the players control (i.e. a weather event in which the golf course becomes unplayable and is closed by the golf course superintendent or Club staff member.)
- If playing golf at The Bridges Golf and Country Club. (Hole in Ones are not awarded if playing at other courses.)
