Non-refundable application fee - R550

ADDITIONAL INFO:

1. Payments are due in advance on or before the first of every month.
2. To qualify for the annual upfront discount, fees need to be paid in full by 31 January 2026.
3. Compulsory camps as communicated by the school may be billed directly to your child's statement or form part of a compulsory Karri Application payment.
4. Only one payment term option can be selected per student account across tuition and fixed services.
5. One change to your payment plan is allowed per year (within cut-off dates).
6. Levies and adhoc services are billed separately and are due in the month billed.

Trinityhouse is now listed as a Public Beneficiary with most major banks and can be found by searching for "Trinityhouse" (ABSA, FNB, Nedbank & Capitec), "Trinity House" (Standard Bank) or "Trinity House Schools" (Investec) on your online banking platform. Should the Public Beneficiary functionality not be in place with your bank as yet, then please utilise banking details provided above when making payments. SD number must be utilised as a reference when making payment.



ADDITIONAL INFO:

7. Sibling discount applies when two or more siblings are enrolled at the same school brand or at The Bridge, in the same academic year. Sibling discount applies from the 2nd sibling onwards, based on grade. The ranking of siblings and associated percentage discount is determined by the student's grade in descending order. See below an example of grades and associated discounts:
 - Sibling 1 (Grade 12): 0%
 - Sibling 2 (Grade 8): 5%
 - Sibling 3 (Grade 2): 10%
 - Sibling 4 (Grade 0): 15%
 - Sibling 5 onwards is capped at a 15% discount
8. A student may only qualify for one bursary or discount applicable per academic year, whichever one is of the highest value.
9. If full payment is not received by 31 January 2026, the account defaults to the 12-monthly payment term or 10 monthly payment term for Grade 12's.
10. Students joining from 1 February 2026 can only choose the 12-monthly payment term.
11. Students joining in January 2026 (after the school has started), will be billed from 1 January.
12. Late joiners from 1 February 2026 onwards will be billed the flat rate for the full month. Monthly fees are not pro-rated for number of days.
13. The academic year runs from 1 January 2026 to 31 December 2026, including all school holidays and public holidays.
14. Final date to cancel for 2026 is 31 July 2026. If leaving after 1 November or notice is given after 31 July, full year fees are due. Notice of cancellation must be provided in writing. The following notice periods are applicable:
 - Application and enrolment fees: non-refundable
 - Tuition fees: 3 calendar months
 - Fixed services: 1 calendar month
 - Adhoc services and levies: non-refundable
15. Credits will be applied on the flat rate for the full month for students leaving before 1 November 2026. Monthly fees are not pro-rated for number of days.
16. Annual payment term must be settled via EFT (no debit orders are available for this payment term). Monthly payments may be settled via EFT or debit order. Only one payment method is allowed per student account. Parents choosing the debit order method must provide banking details and proof of account. Failed debit orders must be settled via EFT. The following debit order dates are available:
 - 1st of the month (in advance)
 - 15th of the month (arrears)
 - 25th of the month (in advance)
17. The debit order processed is the amount reflecting as current on the monthly account statement.
18. Aftercare for Grade 0000 – Grade 0 is included in the tuition fee for 2026.
19. Students collected from aftercare after 18h00 will incur a fine of R 50 per 15 minutes or part thereof.
