Pearson made the motion to appoint Dave Kaup as the Southern Mercer County Joint Ambulance District Rep, this was seconded by Wendel, vote all yes.

Schmitz made the motion to appoint Bert Staugler as Records Commission Rep, this was seconded by Fiely. Vote all yes.

Wendel made a motion to appoint Al Post as Council President, this was seconded by Fiely. Vote all Yes.

Mayor Kaup: I talked to Jerry Guggenbiller good to see he is back to work. The 2021 Income Tax Report was in dropbox. Staugler: It is down, but we were waiting on a large payment last week that did not come in until today. Diller: We received a \$86,000 deposit today. So, the 2021 report is down but it is in 2022. Staugler: 2021 would have been up 3% if the deposit would have been received a day earlier.

RESOLUTIONS/ORDINANCES

Diller: Does anyone have any questions about the Zoning Ordinance after reviewing my comments in drop-box? Pearson: Is anyone living in Indian Heights subdivision required to have approval on subdivision regulations? Diller: It is not listed, but I believe it is best to contact all residents living in the subdivision. They don't like to because it is your neighbor, 50% of all owners must sign off on changes. Accessory buildings seem to be the only time the regulations come up. I think they should work with Dave Kaup. Kaup: It is best to talk to the neighbor on each side of your house because they are the ones that will have to look at it. Diller: I provide the regulations as requested buy I cannot enforce the covenants & restrictions. Pearson: How are the rules enforced if not followed? Diller: The property owners would have to file suit. I think there should be an easier way. Kaup: I think it is the general understanding that the people there should make the decision. No one wants to be the bad neighbor. There needs to be a group in each area to talk to their neighbors. Diller: The process needs to be defined better. They can come to the village to get the information they need. I don't have a problem doing that for them, the downside is everyone thinks I make the decisions. Maybe they should have a Home Owners Association. Maybe Dave Kaup and I can work on something.

ORD 2021-13 AN ORDINANCE ZONING REGULATIONS FOR VILLAGE OF FORT RECOVERY. Schmitz made the motion to pass the ordinance to the <u>third</u> reading which was seconded by Knapke. Vote all yes by roll call vote.

ORD 2022-01 AN ORDINANCE PROHIBITING THE USE OF SNOWMOBILES, OFF-HIGHWAY MOTORCYCLES & ALL-PURPOSE VEHICLES ON STREETS IN FR. Schmitz made the motion to suspend the readings which was seconded by Knapke. Pearson made the motion to pass the ordinance which was seconded by Wendel. Vote all yes by roll call vote.

Diller: The Ohio Revised code was changed; we need to have some way to control use in the village. Schoen: It is up to the Village to allow use. The previous ordinance didn't refer back to state code. Abels: the snowmobiles and all-purpose vehicles are not in multi-use vehicles which is what we had. All the village had to do was to put limitations on the use of these vehicles unless approved by the Chief of Police or Randy. Diller: Such as a severe weather event. We also updated to add under speed vehicles. Abels: The previous ordinance should be under speed and low speed, the previous was low speed only. Diller: We redid the ordinance to include as an all-in-one ordinance.

ORD 2022-02 AN ORDINANCE AUTHORIZING THE USE OF LOW-SPEED, UNDER-SPEED VEHICLES-UPDATED FROM ORD 2017-06. Schmitz made the motion to pass the ordinance to the <u>second</u> reading which was seconded by Knapke. Vote all yes by roll call vote.

Abels: Nothing to report

Diller: Nothing to report on ODOT state reroute.

Utility: We haven't been working on projects much with the holidays.

Wastewater Study: They are to start this week on the study.

Tap Grant: Choice One is working on preliminary design, we will continue to work thru details.

EMA: Nothing to report.

FEMA: We have submitted documentation. I don't think anything will take effect until 2024. Ours are already in place so this does not affect us much.
