

PLAYER TRAVEL WAIVER & RELEASE AGREEMENT

This **Player Travel Waiver & Release Agreement** (“Agreement”) is entered into by the undersigned parent/guardian (“Parent/Guardian”) on behalf of the minor participant (“Player”) and applies to all travel and activities organized, coordinated, or facilitated by **Phoenix Fire Basketball Club** and **South Youth Sports Organization** (“Organizations”).

1. Assumption of Risk

I understand that participation in team travel—whether within Arizona or across U.S. state lines—includes inherent risks such as motor vehicle accidents, injuries during transit, weather hazards, and actions of third parties. I voluntarily assume all risks associated with my child’s travel and participation.

2. Transportation Authorization

I authorize coaches, staff, approved volunteers, and designated parents/guardians to transport my child to and from practices, games, tournaments, lodging, meals, and other team-related destinations. Transportation may occur in personal vehicles, rental vans, or other club-approved vehicles for both **in-state and out-of-state travel**.

3. Recreational & Off-Court Activities

I understand and agree that the team may participate in supervised recreational activities such as **parks, beaches, amusement parks, entertainment venues, walking areas, team meals, and other age-appropriate outings**. I acknowledge that these activities carry risks including slips, falls, water-related hazards, rides, crowds, and general public environments. I voluntarily assume all risks associated with these activities.

4. Release of Liability

To the fullest extent permitted by law, I release and hold harmless the Organizations, their directors, officers, coaches, volunteers, agents, chaperones, and any parent transporting players (“Released Parties”) from any claims or liability arising from travel, transportation, or recreational activities, including ordinary negligence. This release does not apply to gross negligence or intentional misconduct.

5. Medical Authorization

If I cannot be reached in an emergency, I authorize supervising adults to seek medical care for my child and to provide consent to medical personnel. I accept full financial responsibility for any medical treatment.

6. Parent/Guardian Responsibilities

I agree to provide accurate emergency information, communicate any medical or behavioral concerns, and ensure my child follows all travel rules and expectations.

7. Player Responsibilities

My child agrees to follow all team rules, remain with the team unless released to a parent/guardian, behave respectfully during travel and lodging, and follow instructions from coaches and supervising adults.

8. Indemnification

I agree to indemnify and hold harmless the Released Parties from any claims, damages, or expenses arising from my child's actions, my actions, or any violation of this Agreement.

9. Media Consent

I authorize the Organizations to use photos or videos of my child from team travel or activities for updates, promotional materials, and social media.

10. Acknowledgment

I understand that participation in team travel and related activities is voluntary and that this Agreement applies to all Phoenix Fire Basketball Club and South Youth Sports Organization travel activities for the current season.
