**STATE AND LOCAL LAWS DO NOT REQUIRE A CASKET FOR DIRECT CREMATION.** If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers (fiberboard tray).

CREMATIONS AND BURIALS AT SEA: "No dead human body whose death occurred in Virginia shall be cremated or buried at sea, **IRRESPECTIVE OF THE CAUSE AND MANNER OF DEATH**, unless a medical examiner shall determine that there is no further need for medicolegal inquiry into the death and shall so certify upon a form supplied by the chief medical examiner. For this service the medical examiner shall be entitled to a fee established by the Board, not to exceed the fee provided for in subsection D of Section 32.1-283, to be paid by the applicant for the certificate."
