Commitment To Achieving Net Zero

Zydus Pharmaceuticals UK Ltd, a wholly owned subsidiary of Zydus Lifesciences Limited, is committed to achieving Net Zero emissions in the United Kingdom by 2050.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Additional Details relating to the Baseline Emissions calculations.

Zydus Pharmaceuticals UK Ltd is a virtual operation in the UK and was established in 2023. Our emissions data as seen in this Carbon Reduction Plan is reported at a global level by our parent organisation Zydus Lifesciences Ltd.

The calculation tool used for scope 1 and 2 emissions is the United States Environmental Protection Agency and Central Electrical Authority, Govt. of India. Scope 2 emissions are calculated using the location-based method.

Scope 3 emissions account for the following categories as per the GHG protocol:

Category 2 (Capital Goods): Spend Based Method

Category 6 (Business Travel): Spend Based Method

Category 9 (Downstream Transportation and Distribution): Spend Based Method

Category 5 (Waste Generated in Operations): Waste Specific Method

Category 7 (Employee Commuting): Distance Specific Method

Please note, the increase in scope 3 emissions for FY24-25 are due to the additional reporting boundaries in comparison to baseline figures (from 2 categories to 5 categories).

In the current reporting year (FY 24-25) the below theoretical figures represent UK only operations, which are included in the figures reported at group level:

- Total Energy Consumption: 55.26 MWh
- Total GHG Emissions: 9.44 tCO₂e
