

# ALL SAINTS PARISH COUNCIL MEETING MINUTES

November 18, 2025 @ Zintkala Hall – Cherry Creek, SD @ 4:30pm

**OPENING PRAYER** – Led by Fr. JP meeting started at 4:40pm.

## APPROVAL OF AGENDA & MINUTES

- Agenda was approved with one addition to add Alvino for information only to bank accounts – all in favor.
- Minutes were approved with no amendments – all in favor.

## APPROVAL OF 1<sup>ST</sup> QUARTER FINANCIAL REPORTS

Alvino Roybal reviewed the first quarter financial reports noting a few special points.

## CHURCH REPORTS

No discussion on this point for lack of time.

## OLD BUSINESS

- **EB Property Lot Sale** – Paulette Rowley will buy the lots and Fr. JP is working through paperwork with Four Bands and Paulette Rowley.
- **Thunder Butte Land Sale** – Fr. JP has not received an official offer from the CRST on the land offered to them in April. It was decided to offer the land to the Starr Family.
- **White Horse Land Sale** – Bishop gave permission for this sale. Fr. JP will write letter to CRST offering it for sale.
- **WSDCF Investment Fund** – Fr. JP gave a clarification from last meeting that instead of a 3-year investment, the 250K put into the WSDCF is a 5-year investment. We could hypothetically withdraw the amount any time we wished, but it was a goodwill agreement to leave the money invested for 5 years.

## NEW BUSINESS

- **All Saints Stained-Glass:** Fr. JP asked for approval of a contract for stained-glass windows for All Saints sanctuary. The contract was reviewed and the windows will cost nearly \$40,000 to complete. Dale motioned to approve the unbudgeted expenditure, Tate seconded, all in favor. Fr. JP will draw up a corporate resolution and send a letter requesting permission of the Bishop.
- **Cherry Creek Church Inspection:** Fr. JP called Bob Cronan – a Catholic parishioner of the Cathedral in Rapid City and a professional building inspector who inspected the church

in Cherry Creek on Monday November 17, 2025. Bob gave a detailed report to the parish council members present about the state of the building. Overall: it is salvageable but is in need of some significant immediate attention for damage control; especially urgent is a gutter system and belltower repairs. Alvino will pursue some ideas for getting bids and estimates on a gutter system and perhaps foundation restoration before next meeting.

- **Bank Account Information:** Hayden motioned to approve information-only Access for Alvino Roybal to the church accounts at State Bank of Eagle Butte. Dale seconded the motion. All in favor.
