Chapter Officers and Elections for 2026

President - duties include leading meetings, appointing committees, managing chapter business and finances with the Board of Managers, promoting membership, ensuring compliance with bylaws, serving as a liaison, and representing the chapter to the state and national societies.

Executive Vice President - (often called First Vice President) primarily assists the President, acts in the President's absence, and is often responsible for the chapter's membership recruitment efforts, including identifying and encouraging new members. May participate as Chapter representative to Board of Governors.

Second Vice President - fills in for the President and First Vice President when they are unavailable and often chairs the chapter's Education Committee, leading youth-focused Americanism programs and the teacher award program. May participate as Chapter representative to Board of Governors.

Chapter Secretary - primary duties include recording and preserving meeting minutes, conducting general correspondence, providing meeting notices, maintaining the chapter's official records (including the Constitution and bylaws), preparing quarterly reports of the chapter, and furnishing mailing lists to the Registrar.

Treasurer - collects and safeguards chapter funds, manages dues and fees, deposits money into an approved bank account, pays authorized expenses, and provides regular financial reports to the chapter's Board and members. They are responsible for maintaining accurate financial records, preparing an annual report, submitting accounts for an annual audit, and ensuring funds are used in accordance with the chapter's bylaws and budget.

Registrar - guides prospective members through the application process, reviewing applications for completeness and accuracy, maintaining Chapter records, ensuring compliance with NSSAR documentation standards, and submitting completed applications to the State Registrar for further processing. They serve as a local contact and sponsor, helping applicants find a SAR sponsor and understand the genealogical requirements for membership.

Chaplain - duties primarily involve providing spiritual care to members, opening and closing meetings with prayer, coordinating memorial services and resolutions for deceased members, and serving as the chapter's religious and spiritual leader. They also advise the chapter on spiritual matters, consult with families of the deceased, and coordinating with chapter Secretary to report deaths to the state chaplain.

Volunteer Positions Needed to be more effective in our mission.

Children of the American Revolution – Sumter previously hosted the *Gamecock Chapter* CAR. Revitalizing this chapter is a pathway to recruiting younger generations, their parents, and advancing the SAR education mission.

Americanism Committee - promotes the principles of American freedom and liberty by fostering patriotism and educating the public, particularly youth, on constitutional ideals through initiatives like history contests, youth awards, and flag presentations.

Youth Programs Committee - duties include promoting patriotism, fostering appreciation for American history, educating future generations about founding principles, providing community service opportunities, and ensuring a safe and positive experience for youth through adherence to Youth Protection Policies. Chapters fulfill these duties by organizing educational programs, sponsoring youth contests like essay and oration, serving as role models and mentors, and engaging in community and civic activities that align with the broader SAR mission.

Flag Committee - promotes respect for the U.S. Flag through community recognition, educational outreach, and proper disposal of old flags.

Please Consider this:

Six Chapter Meetings per year – we have 4 meetings plus our Christmas gathering. Per the SAR, the quarterly meeting is the minimum acceptable. The new proposal would be six or seven total meetings either adding or including the Christmas gathering.

One option (7 meetings): Jan, Mar, May, Jul, Sept, Oct, and Dec.

Second option (6 Meetings): Jan, Apr, Jun, Sept, Oct, and Dec.
Third option: (6 Meetings): Mar, Apr, May, Oct, Nov, and Dec

Fourth option: 7 Meetings): Jan, Mar, Apr, May, Sep, Oct, and Dec

America 250th Moment

Getting to The Declaration of Independence

Last edition, I focused on the years of intolerable acts that motivated the colonists to seek a better way than living as subjects under a monarch. As 1775 is ending, the British troops are on edge and Colonists this far away from the hot bed of revolution in the New England colonies are preparing for the war to start in the south. During the coming weeks, the question of war will be clearly answered.

As a Sons of the American Revolution Chapter, we should be in the forefront of a civics revival and out there celebrating our history and the American ideals our Patriot Ancestors fought to attain. This coming year should be a celebration of all thing's liberty minded and patriotic. We must celebrate some of the key phrasing of the great Declaration of Independence.

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their creator with certain unalienable rights, that among these are Life, Liberty, and the pursuit of Happiness."

"That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed"

"Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes"

The founding fathers studied the great thinkers of their time and the earlier periods of the Enlightened Age when progressive thoughts centered on the power of individual people to improve society when they understand the ideals of <u>Liberty</u>, <u>Individualism</u>, <u>Self-reliance</u>, and blended that with a healthy skepticism of concentrated authority. Starting with the United Kingdom's 25 Barons wrote the **Magna Carta** (1215), coerced the king to sign it thus establishing the precedence that the King's power and government are not absolute and that citizens have guaranteed rights clearly stated in 63 clauses and sadly only 3 of them remain in force today.

The American Revolution was more than just a Declaration of Independence, it was ushering in the "Era of American Enlightenment" that builds upon the Age of Enlightenment started in Europe. The following are a few of the most outspoken proponents of the rights of citizens the founders studied.

Cicero, (106-43 BC), a Roman statesman, lawyer, and philosopher whose writings were a keystone for colonial leaders. Cicero wrote about Natural Laws and blended elements of monarchy, aristocracy, and democracy to create a "mixed state" utilizing these classical theories.

Sir Edward Coke (1552-1634), an English judge whose interpretations of Common Law are still commonplace and foundational in American Law today. In his writings, he taught people how the Magna Carta was a source of these common law rights.

John Winthrop (1588-1649), a founder of the Massachusetts Bay Colony and Colonial governor, he was a Puritan and his visionary "City upon a Hill" sermon pictured pious, tightknit communities serving as models for other towns and cities.

Roger Williams (1603-1683), was banished from Massachusetts for controversial sermons, he founded Rhode Island based on religious freedom along with the separation of Church and State both of which were ideas far ahead of his time.

These are more contemporary to the founding fathers, also advocates for free people in a free society. **John Locke** (1632-1740), an English philosopher, he argued people are born with inalienable rights to "Life, Liberty, and Property" which became *Happiness* in the 1776 Declaration of Independence.

Baron de Montesquieu (1689-1755), a French philosopher who argued that political Liberty requires a separation of powers with distinct Legislative, Executive, and Judicial branches. This is a core concept our Constitution with it's checks and balances on government excesses.

James Oglethorpe (1696-1785), British general and philanthropist, founded the Georgia colony as a social experiment for debtors and the poor.

Adam Smith (1723-1790), a Scottish economist who introduced the idea that individual self-interest in a free market benefits society.

Benjamin Franklin (1706-1790), a prolific author, inventor, scientist, diplomat, and statesman was very influential with his writings, inventing the improved cast iron stove, his influence in the colonial government, plus securing our alliance with France and negotiated the Treaty of Paris to end the war.

Thomas Paine (1737-1809), a writer and political pamphleteer was a strong advocate for independence with his 1776 writing, *Common Sense* grounded in Enlightenment principles with a healthy dose of rationalism and republicanism he argued for American independence.

Thomas Jefferson (1743-1826), the principle author of the Declaration of Independence to articulate the core American ideals of Liberty, Equality, and Natural Rights.

James Madison (1751-1836, called the "Father of the Constitution" for being a central figure in drafting it, he was a tireless advocate for ratification with the first ten amendments being the Bill of Rights to protect Liberty. He authored 29 of the 85 *Federalist Papers* using the pseudonym "Publius".

John Adams (1735-1826), a lawyer and diplomat, his 1776 pamphlet, *Thoughts on Government* influenced many state constitutions with his advocating three independent branches of government.

Benjamin Rush (1746-1813), a doctor and leading medical scientist advocated for public heath, improved treatment for mental illness, and researching common diseases like yellow fever..

These are a sample of the extraordinary people and great thinkers who articulated their ideas about Life and Liberty which fueled the American Ideal of the government answering to the people. We should be celebrating these ideas and concepts while reminding others of this history in founding our nation.

Jeff Sikkenga and David Davenport of the Ashbrook Center wrote, *A Republic, If We Can Teach It,* shared this, "[C]ivic education should be an 'all hands on deck' project, not just a school curriculum. Civic education needs to be embraced and encouraged in families and civic associations and by government and other leaders in our society. It needs to be understood as a high priority for the nation, embraced and encouraged by everyone. Civic education needs to be 'caught' as well as 'taught.'"

Our patriot ancestors risked their lives, their fortunes, they put their honor on the line supporting the American Cause. We should be willing to put our skin in the game to help others understand Colonial History and inspire their want to learn more about the history of our Republic.

According to Martin Luther King, Jr, "Liberty has never come from the government. Liberty has always come from the subjects of it. The history of liberty is a history of resistance." Our educational outreach must teach the younger generations to understand *Liberty* as the founders envisioned it.

Creating Your SAR Kit

Being in colonial clothing character can really add to your experience as a chapter member. Being "in character" invites people to start a conversation about who you are, your outfit, and you can work that into a conversation about ancestry. It might be just the spark to create interest in a new member joining us.

You don't require exact "period correct" military attire to participate in the SAR. Sumter was in the backcountry, and civilization was Charleston in the 1700s. Also, people were subsistence living and the militia members were community defense forces. They were self-provisioning to survive. They are purchasing their own firearms and the necessary equipment including details like having 12 flints, at least 20 musket balls, one pound of powder plus a powder horn, and cartridge box to store prepreped ammunition. For foot soldiers, items like a pistol, bayonet, or sword were not required. Building a minimal kit that puts you "in character" is a great start to do more.

Our most basic needs do not require a fancy military uniform or a musket. Color Guard members and event participants, those are the forward projection of our chapter or what the public sees or thinks of when the SAR is mentioned.

You can "look the part" of a patriot part with a basic hunter's outfit. You don't need a complete SC Regimental uniform along with an expensive Pedersoli reproduction 1777 musket. For a complete Color Guard team, we need four flag bearers, just two musket bearers and maybe one person as a sword bearer.

Create your simple backcountry outfit: Pants of the era, typically canvas, either in breeches (knee high) or overalls (full length pants). You can find white canvas at Tractor Supply in your size. Get two pairs and have the back pockets removed. To create breeches, have your favorite seamstress cut off the legs of one pair about 1 to 2 inches below the knee then add a hem with either buttons or a draw string to keep them in place below the knee. Use the material from the legs to create drop front look for both pants options. Get knee high stockings to go with the breaches and gaiters for the lower pants leg along with plain toe shoes, faux shoe buckles, and you have footwear and pants for the Patriot Ancestor look at SAR functions.

For the upper body, a linen shirt is available from many online sellers at a reasonable price. Finish your look with a Hunter's Frock and pants (gaiters optional). For an alternative look with your breaches, a waist coat was a required item of the era along with a top coat. Add in a period correct hat (hunter or tricorn), and you're ready to participate in Chapter events "in Colonial Attire." All totaled, you can assemble a reasonably priced kit to be a hunter or backcountry man which was basically what these Patriots wore as their regular clothing and militia uniform prior to and during the war.


