I. Alternate Trust Plans:

A. Basic Revocable Trust Plan (Single Person)*.....	\$2,250
B. Basic Revocable Joint Trust Plan (Husband and Wife with Non-Taxable Estate*).....	\$3,250
C. Joint Revocable Trust (Husband and wife with Non-Taxable Estate with Special Family Needs/Second Marriage Planning).....	\$4,500
D. A-B Revocable Trust Plan (Husband and Wife with need for Estate Tax Planning**).....	\$5,500
E. Irrevocable Trust Plan (For Nursing Home Protection).....	Individual \$3,250 Couple \$4,250
F. IRA Trusts.....	\$600/each
G. Continuing Trust shares for children (or other beneficiaries).....	\$350/each
