BASIC SERVICES OF FUNERAL DIRECTOR & STAFF.....1495

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.) Our Services include, but are not limited to; personnel available 24 hours a day, 365 days a year to respond to initial request for arrangement conference with family or responsible party, shelter of remains, obtaining necessary authorizations and permits, coordinating service plans with churches, cemetery, crematory, or other third parties involved. Our services also include a proportionate share of overhead costs relative to this facility such as licensing, bookkeeping, insurance, building and utility expense, grounds maintenance, taxes, equipment, furnishings, inventory costs, administrative expenses, and governmental compliance.

EMBALMING.....595

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

EMBALMING of Tissue Donation/Autopsy Cases.....795

AQUA CREMATION "Alkaline Hydrolysis".....1850

The charge for aqua cremation includes minimal basic services of funeral director and staff, removal of remains, transportation to the aqua cremation facility. This fee does not include use of facilities and staff for any visitation or ceremony or urn. Alkaline hydrolysis is a final disposition process involving dissolution of human remains by placing the remains in a dissolution chamber containing water and chemical solution including potassium hydroxide or sodium hydroxide, or a combination of both, and introducing heat to break down the remains until bone fragments that may be pulverized and liquid remain.

DIRECT CREMATION.....1295-2,995

The charge for a direct cremation includes minimal basic services of funeral director and staff, removal of remains (1 staff member), transportation to crematory and cremation. (This fee does not include use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation). If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a cardboard box and Trayview (with or without interior).Online Discount 150

IMMEDIATE BURIAL (No family present).....1,595-4,600

This charge includes basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains, 7 days of refrigeration, and local transportation to cemetery Monday-Friday. (This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial, or any cemetery fees)
