The Bremer County Fair Association reserves the right:

- To accept or deny any Commercial Exhibit Contract for any reason.
- To terminate the Commercial Exhibit Contract with any vendor who misrepresents their products and/or services or any vendor that is deemed detrimental to the Fair.
- Pursue legal action against any vendor whose payment cannot be negotiated with the costs of this litigation to be paid by the commercial exhibitor.
- To void the Commercial Exhibitor Contract without refund for any exhibitor that violates any of the rules or requirements set forth in this contract.

SECURITY: The Bremer County Fair and its directors are NOT responsible for any thefts, vandalism, damage or loss of items to any vendor booths/exhibits at the Bremer County Fair. Bremer County Sherriff Deputies on site are provided overnight to deter any potential theft, vandalism, damage and/or loss of booth/exhibit items. Each vendor is ultimately responsible for monitoring and securing the safety of their items.

NOTE: There is no guarantee of any sales for any exhibitors, nor will any commercial exhibitor have exclusive rights to any product(s). Items such as silly string, stink bombs, smoke bombs, fireworks, sparklers, pop pop snappers, knives, lighters or any item that could be deemed inappropriate for kids is hereby prohibited from the Fair. Any exhibitor found to be selling any of these items that were not previously cleared by the manager will be asked to leave immediately for the remainder of fair and booth fee will not be refunded.

To Sign up, please completely fill out this Commercial Exhibitor Contract and return to Eric Ver Steegt by **July 1st** with full payment to reserve your commercial exhibit booth space. After July 1st, a \$50.00 late fee will apply and must be included with the contract to reserve an exhibit booth space.

SET UP may be anytime from 8am-5pm Sunday July 26th, or anytime from 8am-12pm on Monday July 27th. Vendors must be ready to open at 12pm on Monday July 27th. Removal of all commercial exhibits may begin at 8pm on Saturday, August 1st and must be completed by 2:00 PM on Sunday, August 3rd.

HOURS, Vendor/Exhibits Business Hours will be from,

12pm - 7pm Monday July 27th through Friday July 31st and 10am - 8pm Sat. Aug. 1st
Vendors are allowed to be open any extended hours they prefer, but are required to be open during the regular hours as presented above.
