6:00 – 6:45 pm Approximate time to return to your home depending upon your pickup location.

- **Make checks payable to MCCOA (Mercer County Council on Aging) and mail to 217 Riley Street, Celina, OH 45822.**
- Deposit required within 14 days of making your reservation to confirm your reservation.
- Balance due 7/27/26. Additional trip information and billing will be sent prior to that date.
- List of passenger names will be included in final itinerary.
- **Cancellation Policy - Deposit fully refundable up to 30 days prior to trip departure; 30-15 days prior to departure– 50% of your trip cost is non-refundable; 14 days prior to departure – 100% of trip cost is non-refundable. If replacement is found, you will be refunded all your money except for a \$25.00 per person cancellation fee.**
- If less than 30 passengers sign up for this trip, MCCOA reserves the right to cancel the trip or make any necessary changes to conduct the trip with a reduced number of passengers.
- Parking will be available in the parking lots at all locations. **Please plan to arrive approximately 15 minutes prior to the scheduled departure time.**
- The dress for attractions is casual.
- You may bring snacks and drinks on the bus.

Buses are not accessible by wheelchairs. You must be able to get on and exit the bus without assistance. In the event I would need any type of medical treatment, I hereby consent to treatment by any licensed physician or dentist, and I am responsible for any expenses incurred due to any change in the tour.
