The funeral home shall not be liable for the non-appearance of equipment or devices, nor for cemetery property locations, depth, descriptions or plans.'

The warranties granted in connection with the merchandise furnished as part of this contract are the express written warranties, if any, extended by the manufacturer of such merchandise.

When services purchased include traditional preparation (embalming) of the remains of the beneficiary, no warranties are given as to the results or the feasibility to view said remains. The funeral home staff will execute care and respect in our professional services. Due to disease processes, prior use of medical drugs, chemotherapeutic compounds, other medical compounds etc., there may be problems or failure of the chemicals used in embalming.

Merchandise provided by the purchaser of a service will require a legal statement releasing the funeral home from any and all liability pertaining to the use of such merchandise.

### Description of Itemized Services Provided

#### PROFESSIONAL STAFF & SERVICES

Professional & Staff Services for arrangements & meetings with the family and/or executor, co-ordinating activities, rites and ceremonies

Includes, but not limited to; 24 hour, 365 day on call coverage for consultation, advice and personal attention at time of death, funeral arrangement meetings;

Includes, but not limited to; services of staff and support staff for co-ordination of all activities, rites and ceremonies, before, during and after they have been provided, including services and supplies provided by us, as well as those provided by third party suppliers, such as flowers, death notices, etc, maintaining of facilities, equipment and grounds; staffing of office, telephone and general needs as they arise on premises.

#### DOCUMENTATION, FORMS, PERMITS, ETC.

Completion and filing of all documents necessary to carry out the services and supplies requested, including, but not limited to, death registration, burial permit, coroner's certificate for cremation or shipment out of province, invoices and all general clerical and accounting duties associated with operation of the funeral home; essential record keeping, Provision of 15 Proofs of Death issued by O'Neil Funeral Home (London) Limited. This cost does NOT include fees charged by coroners, City Hall or other government agencies for the actual certificate. This is charged separately. Our proofs of death are usually accepted for most estate settlement purposes, but sometimes a provincial "Death Certificate" will be necessary and is available from the Office of the Registrar General, at an additional cost set by the Minister of Finance

**PREPARATION / HANDLING AND EMBALMING OF REMAINS**

Except for special circumstances such as shipping outside the province of Ontario, embalming is not required by law. Traditional embalming is the process of internal and external sanitation and disinfection. Embalming is a temporary process, and there can be occasions when it will be our professional advice that our best effort will not be enough to dignify the situation.

**BASIC PREPARATION OF REMAINS**

In place of traditional embalming, this is the preparation, sanitation, and dressing of the body for placement in the casket, in compliance with the wishes of the family and in respect to their cultural tradition. This includes, if required, the setting the facial features for identification of the remains either in person or by photograph, the removal of a pacemaker; Use of a sealing vinyl pouch or a metal sealing liner might be required in some cases.

**Basic Identification**

Identification on premises is for a period of no more than five minutes for a maximum of five people, and is not a substitute for a regular visitation period.

**USE OF FACILITIES TO PREPARE & SHELTER REMAINS**

The preparation room is used for embalming, sanitation and alternate preparation of the human body. It must meet stringent sanitary and environmental standards as mandated by law which includes Board of Health and the Ontario Funeral Services Act requirements as well as provide a dignified setting. Included is the Refrigerated Shelter of Remains when applicable.

**INTERNATIONAL SHIPPING, INCLUDING DOCUMENTATION – PERMITS, FORMS, ETC.**

We are South-Western Ontario's leading shipping specialists with 50 years of experience in this field. We have found that documentation necessary to ship the body out of the country varies greatly with the country we are shipping too, and these charges are subject to change at the last moment by governments in both Canada and around the world. We will be happy to provide estimates at time of need. The final price will depend on the amount of documentation needed by each country and the time needed to complete all required documentation.

**FACILITIES & EQUIPMENT FOR VISITATION AND COMMON AREAS**

Includes, but not limited to, use of all common areas such as the main lobby, our large parking areas, washrooms, coffee lounge, casket display room and all other common areas as are required to operate the funeral home; family areas such as the visitation parlour; use of all furniture, casket biers, flower stands, podiums, religious equipment, donation stands; upkeep and basic maintenance of all facilities such as carpeting, lawns, furniture, heating & cooling, etc; maintenance and monitoring of all security alarm & video systems.

**FACILITIES & EQUIPMENT FOR SERVICES & CEREMONIES, AND COMMON AREAS**

St. Dismas Chapel: Seating for 160 persons, the Chapel is available for funeral services. Includes an organ (but not an organist), professional sound system, large screen television with laptop, and other equipment such as flower stands, podiums, religious equipment, donation stands, etc.

**LIVE STREAMING SERVICE**

Live streaming of a funeral service or visitation is available in our chapel only, at an extra charge, subject to conditions. All people attending must be made aware that they may be photographed and/or filmed live on the internet.

Although SOCAN rules ([www.socan.com](http://www.socan.com)) permit the use of commercial music and songs for a funeral service without royalty fees in Canada, live streaming services such as YouTube, Facebook, Twitch and others do NOT recognize "broadcast rights" of commercial songs played at a funeral service. All of these services will frequently mute, on their own, without any warning, in part or in whole, a funeral service that plays any commercial music. We have no control at all over this situation.

## Automotive Equipment and Transportation

### INITIAL TRANSPORT OF REMAINS

24 hour coverage, 365 days a year. The initial transport would include one person in attendance at a hospital or nursing home and returning to the funeral home. If death occurs at private residence a charge for a second staff member will apply. Additional transport examples would include, but not limited to, delivery of the remains to a specified Church, Temple, Mosque or other place of service or worship, a specified cemetery or a specified crematorium. A charge will be applied for each transportation request. We define "local" as the City of London. Outside of this area is subject to out of town charges.

### LEAD / CLERGY CAR

Includes the driver. Usually a 4 door sedan used to lead the funeral procession, provide transportation for attending funeral home staff, and clergy when needed. Also would include private delivery of cremated remains to local cemetery

### FUNERAL COACH

Includes the driver. Full sized Lincoln based Vehicle used for transport within City of London as defined above, transport casketed remains to and from Funeral Home to a Church, Mosque or other place of service and worship, to cemetery or crematorium, or to the London Airport.

### SERVICE VEHICLE

Includes the driver. Vehicle used in place of the full sized funeral coach for transport within City of London as defined above, transport casketed remains to and from Funeral Home to a Church, Mosque or other place of service and worship, to cemetery or crematorium, or to the London Airport.

### ADMINISTRATION VEHICLE

General duty vehicle used to register the death, pick up cremated remains from the crematorium, make off-site arrangements, etc.

### VEHICLE FOR FLOWER DELIVERY

Includes the driver. Delivery of flowers to no more than two locations inside the city of London.

### LIMOUSINE

Includes the driver. Usually a four or six door stretched vehicle used to provide transportation for family members. Prices vary on the size of Limousine required.

## PROOF OF DEATH CERTIFICATES

Every service listed in this document includes fifteen (15) copies of the Funeral Director's Proof of Death certificate. Additional copies are available at \$20.00 each.

Please note that due to concerns with the Privacy Act and the Vital Statistics Act, it is company policy not issue Proof of Death Certificates when we are unable to confirm that the person requesting the certificates has the legal right to them, or when the death has taken place more than twenty years ago. Funeral Homes are under NO legal obligation to issue a proof of death certificate to anyone, even to the Executor/Estate Trustee, save rare circumstances when issued a warrant to do so by the Crown.

It is our personal experience that with the rise of identity theft, our recommendation is that executors and/or next of kin exercise caution to whom they give proof of death certificates to.

If an estate is administered by a government agency such as Discretionary Benefits of the City of London, the Ontario Guardian and Public Trustee, or the Children's Aid Society of Ontario, then the law states that any and all copies of the Funeral Director's Proof of Death Statements shall be given directly to the agency involved and not to any family member.

**GENERAL INFORMATION**  
**From Whom Do We Take Instructions For Funeral Service Arrangements?**

**THE EXECUTOR/ESTATE TRUSTEE IS KING/QUEEN**

The Executor, properly called the Estate Trustee under Ontario law, or a court appointed Administrator of the deceased's estate, always has priority over everyone else. We must find out, in every case, if there is a Will, who the Executor is, and, if the situation demands it, get a copy of the Will or other proof that the person is indeed the Executor. If there is a dispute over who is the Executor, the law demands that we must have written proof of some kind that names exactly who the Executor is before any final funeral arrangements can be made.

**WHAT HAPPENS WHEN THERE IS NO EXECUTOR/ESTATE TRUSTEE?**

When there is no Executor or Administrator, common law (or case law) provides that the next of kin has the right to make the funeral arrangements.

**THE SPOUSE IS KING/QUEEN**

The spouse of the deceased is the husband or wife or the person of the opposite or same sex with whom the deceased was living in a conjugal relationship before their death.

**WHAT IF THERE IS NO SPOUSE?**

If there is no spouse, the person most likely to be appointed administrator of the estate should make the arrangements. Those people are in the following order of priority:  
1st Spouse; 2nd Children; 3rd Grandchildren; 4th Great-grandchildren; 5th Father or Mother; 6th Brothers or Sisters; 7th Grandparents; 8th Uncles, Aunts, Nephews, Nieces; 9th Collateral relatives (cousins etc.)

If the deceased is a minor the parents take priority and the above does not apply.

**NOTES:**

- While the proper term in Ontario is now "Estate Trustee" in place of "Executor", this is not true for all jurisdictions, especially many foreign countries where the proper legal term is still "Executor". Because of the large number of international shipments we conduct, and the need to satisfy both Canadian and International laws that is required by many of our clientele who have estates outside of Canada, all of our documentation, contracts and price lists use both terms concurrently.

- Individual government agencies define the term "Common Law Marriage" in different ways; some recognize a brief time period, some 1 year and some 3 years. Some governments such as state governments in the United States do not recognize common law relationships at all and this can present difficult legal issues for people who have dual citizenship when trying to settle estates on both sides of the border. For example, what might be acceptable in Ontario under a Common Law relationship might either be unrecognized or illegal in some international jurisdictions. If you have any international estate considerations we advise people to make sure they have an Executor/Estate Trustee.

- Minors or persons who are under the age of eighteen years, cannot write legal wills nor appoint an executor. Any will written by a person under the age of 18 years, regardless of their current age, is not recognized by the courts.

- Government agencies such as Discretionary Benefits of the City of London, the Ontario Guardian and Public Trustee, or the Children's Aid Society of Ontario cannot authorize either embalming or cremation, usually only a family member can do either. A Coroner or Medical Officer of Health in extreme circumstances can authorize either for the sake of public health.

- An Executor/Estate Trustee has the right to change, amend or cancel any pre-arranged funeral service contract, or any directions as to the final disposition of your body, including cancelling signed organ donor cards. Common Law clearly states that "You Cannot Rule From The Grave." Choose carefully who your executor is. Trust Companies and Law Offices are often closed on holidays and weekends, and if a death occurs on these dates, it might not be possible to make any arrangements for a few days.

- If there is no Executor/Estate Trustee, and the family wishes cremation, then the local crematoriums are asking that every "immediate" next of kin over their age of 18 years, including but not limited to spouses and children, must agree in writing to the cremation. If not all family members are available at the time of death to agree, it may not be possible to cremate. Our advice is to have a will and an Executor in all situations, but especially if cremation is planned.

**Direct Burial/Cremation Service**

*Direct Cremation or Direct Burial at cemetery or crematorium in the City of London.  
 No service or visitation of any kind.*

The Minimum Services charge represents the minimum non-declinable services required to facilitate the disposition of a deceased person, whether by cremation or burial .

This minimum service charge is applicable to every family we serve and includes transferring the deceased from the place of death (or Coroner's Office, hospital, airport, etc.) to our refrigerated morgue, where the deceased will be placed in a casket\* of your choosing and securely held until the necessary documentation is completed for burial or cremation as applicable. Once the required documentation is ready (i.e. death has been registered and if applicable, the coroner's certificate for cremation / hydrolysis has been obtained), the deceased is transported in a service van or SUV to the cemetery and/or crematorium at the earliest practicable opportunity or at a scheduled time, as applicable.

Additional fees may apply for mileage beyond 122 km (round trip), pacemaker/radioactive implant removal, any private family identification, disbursements to be paid to third parties on your behalf, such as the cemetery interment fee, crematorium fee, coroner's fee, death registration fee, etc.

## **Notes About Cremation**

O'Neil Funeral Home (London) Limited does not own or operate a crematorium itself. We have always used one of the local independent crematoriums here in the city of London such as Woodland Cemetery or Mount Pleasant Cemetery. Sometimes when a death occurs out of town, depending on distance, we can arrange for a cremation to take place outside the city of London.

Actual fees for cremation are set by the local crematorium at time of need. In the Province of Ontario, all cremations must be first authorized by a Coroner's Cremation Permit, which at the time of publication was \$75.00.

### **1) Authorization:**

Since cremation is a non reversible process, all cremation forms and contracts MUST be signed by the executor and/or estate trustee. In the absence of an executor and/or estate trustee, all immediate adult members of the family must agree and may be required to sign or submit in writing permission before cremation can take place. If a situation arises where the executor or immediate next of kin is either not available or cannot be clearly identified then cremation may not take place.

A separate cremation form and contract for the crematorium must be signed at the time of arrangements and we will provide these forms for either Woodland or Mount Pleasant Cemetery.

### **2) Identification:**

The executor and/or estate trustee, or the immediate next of kin must identify to O'Neil Funeral Home (London) Limited, the true and correct identification of the deceased before cremation can take place. Photo identification is one possible way of doing an identification

### **3) Medical Devices and radioactive treatments:**

The executor and/or estate trustee, or the immediate next of kin must fully disclose to O'Neil Funeral Home (London) Limited, that the deceased does not have any medical devices or implants that may impair or prevent cremation, including but not limited to a pacemaker or any recent radioactive treatments before the cremation can take place.

### **4) Possession of Cremated Remains and Refundable Deposit:**

If authorized in writing and subject to a refundable deposit of \$350 , O'Neil Funeral Home (London ) Limited Will take possession of cremated remains and will retain the cremated remains for ONE YEAR from the date of cremation. If the cremated remains are not claimed within one year, the O'Neil Funeral Home (London ) Limited may inter the cremated remains in a cemetery, in a common lot for which the cemetery is the interment rights holder, and the O'Neil Funeral Home (London ) Limited Will retain the deposit referred to in this section. If the cremated remains are claimed before they are interred, O'Neil Funeral Home (London) Limited will refund any deposit paid.

### **5) Cremation Fee**

At the time of publication, the fee for cremation at Woodland Cemetery, London, Ontario, was \$487.00 plus the HST. This fee is subject to change without notice.

## Traditional Funeral Services

A "Traditional Funeral Service" is where the deceased and casket are present for visitation and/or a funeral service, followed by interment, entombment or cremation in a cemetery. Overtime rates apply on Weekends and holidays.

### Two Day Traditional Funeral Service

One day of visitation followed on the second day by a funeral service.

This package includes all services in the Minimum Services charge, plus: four hours of visitation at the funeral home, followed by a funeral service the next day in our chapel, or at a local church or other local venue selected by the family.

Also included is embalming, dressing and basic hairdressing services; professional staff supervision and guidance throughout the visitation and service; the use of a visitation suite including equipment to display personal items and floral tributes; the use of our facility on the day of the funeral service, or the assistance and direction of our staff at a church or other venue; flower/equipment vehicle, and funeral coach (in lieu of a van or SUV) to the cemetery or crematorium, as applicable

These rules vary greatly and change often, but we are happy to find out at the time of need if you are planning on taking cremated remains outside of Canada.

When a body is cremated at either Woodland or Mount Pleasant Cemetery here in London, the cremated remains will be presented in a box that is suitable for interment or scattering as is.
