- turn left at Wendy's onto 460 East
- drive 2.9 miles and turn left into The Heritage subdivision
- Drive **Slowly** straight through subdivision, grass parking area will on your left, the indoor arena and barn are on your right.

From Paris (460 West)

- at [922 \(Newtown Pike\)](#) and 460 intersection, stay straight onto 460 west -drive .3 miles
- turn right into The Heritage subdivision
- Drive **Slowly** straight through subdivision, grass parking area will be on your left, the indoor arena and barn are on your right.

Post Entry Fee: +\$50 after closing date **of April 30, 2026.**

Entry Fee Refund Policy: Entries will be refunded in full before closing date of **04/30/26**. After the Closing Date, refunds will only be issued with a note from a medical professional (Doctor or Veterinarian) minus the office fee of \$25.

Stall Fee: \$150 (Wed-Sun) Stalls must be stripped or pay \$50 cleaning fee. *We have limited stabling. No tack stalls will be permitted unless we have additional stabling after all entries are processed. If you wish to be put on a waiting list for a tack stall, please note on entry. Additional Comments or Fees: Show Pass Fees: Any rider, handler, driver, or owner are limited to one Show Pass purchase annually (Dec. 1 – Nov. 30). USEF Show Pass will be available for purchase by exhibitors on-line only. Competitions cannot accept payment for Show Pass fees. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for Show Pass and must obtain a Senior Competing membership to participate in a USEF licensed competition.

MEMBERSHIP STATEMENT: Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at Modified Level or above, and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competition and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass Fee. Participants in the following classes are exempted from the requirements of this rule: 1) Leadline; 2) Exhibitions; 3) Games and races; 4) classes for 4H members; 5) Walk Trot and Academy Classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF Introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

2. Download the Equitrac App. (See instructions on page 11 of prize list). Record horse info in the app, then upload health documents (Coggins, Vacc Cert, Health Cert for out of state horses). You will be given a Show Pass QR Code that will be scanned on entry to the farm.

3. All Entries Must include a Signed USEF Entry Agreement, USEF KY Waiver, and a Charlotte's Creek Farm Waiver.
4. The USEF Entry Agreement, USEF KY Waiver, and Charlotte's Creek Farm Waiver must be signed by any grooms or navigators riding on the carriage.

Restrictions, if any, to multiple times on course: Maximum 2x on course: Applies to Driver, Groom, and Equipment.

Sharing: Drivers and/or navigators may go round the marathon course a maximum of 2 times if the schedule allows. This also applies to sharing of carriage or harness. Competitors wishing to share navigators, drivers acting as navigators, carriages or harness must complete the Special Request for Sharing Form. Failure to complete the form will result in the request not being honored. This form must be received in the show office no later than 3PM, Friday, May 15, 2026.

Sharing requests cannot be guaranteed due to scheduling constraints. The Organizing Committee reserves the right to limit sharing requests for marathon to a maximum of one hour extension of the schedule. Requests that stretch the schedule of more than 1 hour may be subject to a \$50 sharing fee to cover the additional costs of the Emergency personnel.

MOTOR VEHICLE STATEMENT: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management at their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed unsafe use if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Veterinary and Health Requirements: Flu and Rhino Vaccination certificate within 6 months of show date. A negative Coggins test is required for every horse entering the show grounds (valid within 1 year of the start of the show). A Health Certificate issued within 30 days is required for horses entering Kentucky. Daily temperature recordings will be required for all horses. **All Horses must have a Show Pass to enter the facility. Vaccination Certificate, Coggins, and Health Certificate for Out of State Horses must be uploaded to Event Pass. Please follow directions on next page.**

ANIMAL WELFARE: We require that all horses be treated with kindness, respect and compassion, and should never be subject to mistreatment. Owners, trainers, riders, and grooms or their agents must use reasonable care in the handling and treatment of their horses whether owned or placed in their care for competition or for any other purpose. At all times, while the horse is on the show grounds, we will provide for the continuous well-being of the horse. No excessive use of the whip will be tolerated. The well-being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. IN THE EVENT OF AN ACUTE AND SERIOUS INJURY TO OR ILLNESS OF A HORSE ON COMPETITION GROUNDS WHEN THE OWNER OR TRAINER OF THE HORSE OR AGENT OF THE OWNER IS

NOT PRESENT, AFTER REASONABLE EFFORT TO CONTACT THAT INDIVIDUAL HAS BEEN MADE, COMPETITION MANAGEMENT, IN CONSULTATION WITH A LICENSED EQUINE VETERINARIAN, MAY AUTHORIZE THE PROVISION OF EMERGENCY VETERINARY TREATMENT OF THE HORSE. IF COMPETITION MANAGEMENT SO AUTHORIZES TREATMENT UNDER THE PROVISIONS OF THIS RULE, COMPETITION MANAGEMENT AND VETERINARIAN ARE NOT LIABLE FOR ANY RESULTING COSTS, DAMAGES, LOSSES, CLAIM OR ACTIONS ARISING DIRECTLY OR INDIRECTLY FROM THE TREATMENT OF THE HORSE.

Food available on grounds: Yes, food truck Fri-Sun

Per USEF Rule DC919 Stable Security - 1. (1.2) Stable arrangements and security are at the discretion of the Organizer and shall be approved by the Technical Delegate. Arrangements must be made with the Prize List. No Stable Security Provided. Gated property, security cameras on site.

Dog Policy: Pursuant to GR 1301.6 All dogs must always be on a leash and under control. Please do not take your dogs to the dressage ring or the cones ring during competition or take your dog into obstacles. Loose dogs or dogs that are a nuisance will incur a fine and/or a Yellow Card. You will need to come to the show office to pay and to collect your dog. Camping on Grounds: Yes, limited sites are available. Please indicate on entry or contact Jennifer (304) 208-5224, RV Sites are limited (Reserve Early!) \$30/night 30 Amp plus water.

Hotels: Many hotels are available, search HOTELS IN Georgetown, KY, 2-3 miles from farm.

Protective Headgear Rules for All National Classes will be pursuant to GR801 and DC 913 relating to protective headgear and for FEI Classes pursuant to Article 928.

Sharps Disposal- Competition Management may fine any individual up to \$100 for improper disposal of needles or other sharp disposable instruments. Sharps containers are located on each end of the barn. **No-**

Smoking Policy – Charlotte's Creek Farm is a non-smoking facility. Any person caught smoking within 50' of a barn entrance, building, or barn will be asked to leave the facility.

Important Information for Short Format Event Competitors

- **Marathon attire (no shorts) is acceptable in both dressage and cones.**
- **Helmets must be worn during marathon and cones, and it is strongly suggested to wear helmets in all warm-up arenas.**
- **Back Protectors must be worn on marathon.**
- **Veterinarians and Farrier are on call, not on site. Phone numbers are posted at show office and barn aisles.**
- **Pneumatic Tires are permitted in all divisions.**
- **In the Beginner and Training divisions at Short Format Driving Events, verbal outside assistance is allowed in any competition phase, including dressage. The groom or an outside assistant standing by the arena may call out the test for Beginner and Training Level Classes without penalty. Electronic Communication devices may also be used if only one earphone is used at a time while on the carriage.**
- **At short Format Driving Events with a modified marathon, the whole course must be open for inspection by athletes at 12:00 PM (noon) the day before the scheduled start.**
- **At Short Format Driving Events, in the modified marathon, an athlete who fails to pass through a CTF in the published sequence and direction will incur 5 penalties per error (NO Elimination).**

FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulteur or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of _____ (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.1.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

Under Kentucky law, a farm animal activity sponsor, farm animal professional, or other person does not have the duty to eliminate all risks of injury of participation in farm animal activities. There are inherent risks of injury that you voluntarily accept if you participate in farm animal activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
