

SUMMARY ANNUAL REPORT

For Allied Stone Health Plan

This is a summary of the annual report of the Allied Stone Health Plan, EIN 73-1571695, Plan No. 501, for period 01/01/2025 through 12/31/2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Curative Insurance Company to pay and Medical claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2025 were \$2,040,978.

The contracts with Curative Insurance Company are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2025, the premiums paid under such "experience-rated" contracts were \$2,040,978 and the total of all benefit claims paid under these contracts during the plan year was \$1,467,031.
