10. To receive monthly or quarterly reports from contracted service providers regarding run reports, training, call statistics, department rosters, and emergency services activities.
11. To review and discuss the budgets, financial reports, audit letters and expenditures of the contracted service providers.
12. To review and act on matters related to Fire Training Field including the purchase of training tools and props.
13. To review and take action on approval of expenses related to upcoming training classes, course materials, equipment and related expenditures to be incurred by the District.
14. To review and act on issues with dispatching.
15. To review, discuss and act on disposal of surplus equipment.
16. To review, discuss and take action regarding real estate matters.
17. To review, discuss and take action on matters related to Commissioner reappointments.
18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
19. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
20. To act upon matters discussed in closed session.

21. To set the date for the January 2025 regular meeting.
