Our charge for direct cremation without any attendant rites or ceremonies includes basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains, transportation to crematory, necessary authorizations, and cremation. *An additional fee will be required if the decedent's weight is over 300 pounds and will be a separate item on the contract.*

For families choosing direct cremation, a brief private final viewing may be arranged prior to the cremation, and is encouraged by Hullinger Mortuary. This allows immediate family members a quiet moment to say goodbye in a respectful setting. No embalming or public service is included. The private viewing must be scheduled, held within three (3) days from the date of death, and is limited to a one time event for a maximum of thirty (30) minutes and is only open to immediate family of the decedent (parents, siblings, spouse, children, grandchildren) to preserve the simplicity of direct cremation.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is an alternative container made of fiberboard and composite wood that is resistant to leakage or spillage. Utah State code [58-9-609(2)(a)] requires the body to be in a cremation container. Because the use of a cremation container is required by Utah State code, it is included in the above price. *No allowances or discounts will be made if the cremation container is provided by the purchaser.*

**A cremation permit is required by the State of Utah [58-9-607(1)(b)]. Utah State charges a fee for this permit and it will be a separate item on the contract.**

Cremated remains may be shipped to a designated location within the United States using the United States Postal Service (USPS). USPS is currently the only legal method for shipping cremated remains domestically. Per USPS regulations, cremated remains must be sent via Priority Mail Express and visibly labeled as Cremated Remains to ensure proper handling and tracking. Hullinger Mortuary will securely package the cremated remains in an approved container and comply with all required procedures. Fees for this service include postage, packaging materials, and handling.

**Parting Stone Solidified Remains** ..... \$1999.00

We have partnered with *Parting Stone*, and they provide an additional option for cremated remains: an alternative to cremated remains called Solidified Remains.

Solidified remains are a complete alternative to cremated remains that allow you to live comfortably with your departed loved one. The solidification process of the full or partial amount of cremated remains compresses the remains into a beautiful collection of 40-80+ "stones" that you can hold, share, scatter, and travel with.

The appearance of each collection of solidified remains is 100% natural. People can result in different hues and textures making each set unique. This additional option empowers families in their grief by providing a form of remains that can be touched and held.

Note that scheduling for immediate burial must occur within a significantly shorter time frame than other service options.

This charge does not include visitation, rites or ceremonies prior to forwarding of the body. (If the body is to be removed from the state, a burial/transit permit is required. The state charges for this permit and it will be a separate item on the contract.)

You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### **\*BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$2210.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (A portion of this fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and includes coordination with those providing other portions of the funeral, (e.g. cemetery, crematory, vault companies and others as required). Also included in this charge are overhead expenses relative to our facilities such as sheltering of remains, professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.

### **\*EMBALMING ..... \$870.00**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. *If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

Embalming is a surgical procedure and is the chemical treatment for temporary preservation and sanitation of human remains. Embalming helps to retard the decomposition process, enhances the appearance of the human body disfigured by traumatic death or illness, and makes it possible to lengthen the time between death and the final disposition.

Formaldehyde is a chemical commonly used in embalming fluids to preserve the body by temporarily delaying decomposition. It is a colorless, strong-smelling gas that is classified as a potential carcinogen. The primary risks associated with formaldehyde exposure occur during the embalming process and is limited to the embalmer when proper safety measures are not followed. We take proper safety measures including always utilizing Personal Protective Equipment (PPE) and ventilation. Formaldehyde begins to break down quickly into organic chemicals after use and does not pose a health risk to family members or visitors once embalming is complete.

Utah State health regulations [R436-8-4] requires burial or cremation within twenty-four (24) hours of death if no embalming takes place, unless refrigeration is available. Refrigeration is available at our mortuary. If a body is being transferred out of state or by common carrier, it must be embalmed in most cases.

## General Policies

- A headstone, marker, or memorial ordered with Hullinger Mortuary and Hullinger Memorials will not be produced until it and all services have been paid in full.
- Hullinger Mortuary, Hullinger Memorials, and their agents will not receive, design, engrave, set, or place third-party headstones, markers, memorials, rocks, or stones. It is the responsibility of the individual(s) purchasing the headstone, marker, or memorial to learn, know, and follow the ordinances, requirements, and limitations set by the cemetery that you will be placing the headstone in. This can be done by contacting the cemetery directly.
- Jewelry of any kind will not be cremated with human remains. It can be placed in the urn with the cremated remains following the cremation process.
- Hullinger Mortuary requires physical or photographic identification of the decedent prior to cremation services.
- Hullinger Mortuary will not exclude any person(s) from services at the mortuary or at another location if the services have been publicly announced in anyway by the mortuary or by family and friends of the decedent.
- Hullinger Mortuary will not allow viewing of human remains by non-immediate family members of the decedent outside of publicly scheduled services without verbal permission from the next-of-kin.
- Family and friends of decedents are not permitted to ride in mortuary vehicles, including motorized and horse drawn funeral coaches used during services.
- We accept funeral merchandise purchased from third-party providers at no additional cost. However, deliveries must be scheduled in advance, during normal business hours, and must arrive by the business day prior to any scheduled services (for example, if a funeral service is on Saturday and there is a viewing on Friday evening, the item must arrive by Thursday, or if the funeral and viewing are on a Monday, it must arrive by the Friday before). We do not have equipment to unload items delivered by freight methods requiring a loading dock or forklift. We recommend that you or a representative be present to inspect for damage at delivery. We cannot refuse delivery, even if damage is visible. We ask that all packing materials for larger items be removed and discarded by the purchaser.

## Privacy Policies

- We do not disclose any nonpublic personal information about our customers or former customers to anyone, except as permitted or required by law.
- We restrict access to your personal, financial, and account information. That information will only be provided to those employees who need to know that information in order to provide the services you have purchased and to maintain your account.

## Payment Policies

*At Hullinger Mortuary, it is our goal to assist every family, regardless of their financial resources. We have a range of options that can meet any family's needs.*

- Payment shall be made within **thirty (30) days** from the date of the funeral or cremation service. A late penalty of 1.5% per month (18% per year) will be assessed on the unpaid balance for materials and services.
- If a payment plan is established, at the discretion of the Funeral Director in Charge, half of the contract total is due prior to services and then a minimum monthly payment of \$100.00 is required. If a payment is missed interest will be applied.

# Utah State Control of Disposition

In Utah, and most states, the right and responsibility to control the disposition of a deceased person's remains—including decisions about burial, cremation, or other arrangements—are assigned in a very specific order or priority. This hierarchy is firmly defined in Utah Code 58-9-602, and is provided to you below:

**Effective 9/1/2024**

## **58-9-602. Determination of control of disposition.**

The right and duty to control the disposition of a deceased person, which may include cremation as well as the location, manner and conditions of the disposition, and arrangements for funeral goods and services to be provided, vests in the following degrees of relationship in the order named, provided the person is at least 18 years old and is mentally competent:

- (1) the person designated:
  - (a) in a written instrument, excluding a power of attorney that terminates at death under Section 75A-2-110, if the written instrument is acknowledged before a Notary Public or executed with the same formalities required of a will under Section 75-2-502; or
  - (b) by a service member while serving in a branch of the United States Armed Forces as defined in 10 U.S.C. Sec. 1481 in a federal Record of Emergency Data, DD Form 93 or subsequent form;
- (2) the surviving, legally recognized spouse of the decedent, unless a personal representative was nominated by the decedent subsequent to the marriage, in which case the personal representative shall take priority over the spouse;
- (3) the person nominated to serve as the personal representative of the decedent's estate in a will executed with the formalities required in Section 75-2-502;
- (4)
  - (a) the sole surviving child of the decedent, or if there is more than one child of the decedent, the majority of the surviving children; and
  - (b) less than one-half of the surviving children are vested with the rights of this section if they have used reasonable efforts to notify all other surviving children of their instructions and are not aware of any opposition to those instructions on the part of more than one-half of all surviving children;
- (5) the surviving parent or parents of the decedent, however:
  - (a) if one of the surviving parents is absent, the remaining parent is vested with the rights and duties of this section after reasonable efforts have been unsuccessful in locating the absent surviving parent; or
  - (b) if the parents are divorced or separated and the decedent was an incapacitated adult, the parent who was designated as the guardian of the decedent is vested with the rights and duties of this section;
- (6)
  - (a) the surviving brother or sister of the decedent, or if there is more than one sibling of the decedent, the majority of the surviving siblings; and
  - (b) less than the majority of surviving siblings, if they have used reasonable efforts to notify all other surviving siblings of their instructions and are not aware of any opposition to those instructions on the part of more than one-half of all surviving siblings;
- (7) the person in the classes of the next degree of kinship, in descending order, under the laws of descent and distribution to inherit the estate of the decedent, and if there is more than one person of the same degree, any person of that degree may exercise the right of disposition;
- (8) in the absence of any person under Subsections (1) through (7), the person who was the decedent's guardian at the time of death;
- (9) any public official charged with arranging the disposition of deceased persons; and
- (10) in the absence of any person under Subsections (1) through (9), any other person willing to assume the responsibilities to act and arrange the final disposition of the decedent's remains, including the personal representative of the decedent's estate or the funeral service director with custody of the body, after attesting in writing that a good faith effort has been made to no avail to contact the individuals referred to in Subsections (1) through (9).

# Frequently Asked Questions (FAQ)

## **Q: Is a viewing needed or even necessary?**

A: Yes. Viewing the body of a loved one, whether during a private family viewing or public viewing, can play an important role in the grieving process. It allows family and friends to say goodbye, acknowledges the reality of the loss, and begin to process their emotions. For many, seeing the person at rest brings a sense of closure and comfort. Viewing human remains is a personal choice, but it can offer a meaningful opportunity for reflection, connection, and healing—especially when supported by cultural, spiritual, or family traditions.

## **Q: Can I pay for my cremation/funeral services and grave spaces while I am still alive?**

A: Yes. This is called pre-planning and pre-funding and it is a great option to decrease future burden on your surviving loved ones. Purchasing cemetery spaces can be done by contacting the cemetery directly. Please ask one of our funeral directors for contact information if you aren't sure. Pre-planning and funding of all other services can be done with our expert Pre-need Insurance Agent.

## **Q: Can I still have a service if I want to be cremated?**

A: Yes. Many families give permission to embalm the decedent and choose to have a private viewing, a public viewing, and/or funeral services before the cremation. A memorial service can also be held after the cremation. Choosing cremation does not limit your options.

## **Q: I found an urn online, but I'm not comfortable placing the cremated remains in it. Can you do it?**

A: Yes. With an appointment, we will transfer the cremated remains into an urn or container, including cremation jewelry, provided by the family or a third-party at no additional cost. However, we cannot accept responsibility for damage to or the suitability of urns not provided by us.

## **Q: Can cremated remains be shipped to a family member or friend?**

A: Yes, but only through the United States Postal Service (USPS) using Priority Mail Express with special labeling. This is the only legal method for domestic shipping of cremated remains.

## **Q: Do you accept pending GoFundMe (or other crowd sourcing options) funds as a guarantee of payment?**

A: No, crowd source funds are not guaranteed or immediately available to you, especially if organized by someone outside of your immediate family. However, we do offer a secure crowd funding option directly through our website, which ensures timely access to contributions. Please contact us to learn more.

## **Q: Will an AD&D insurance policy from my bank or credit union cover funeral expenses?**

A: Accidental Death & Dismemberment (AD&D) policies only pay out if the death is caused by a covered accident. They do not cover death from illness, natural causes, or suicide, and many claims are denied. If you're relying on an AD&D policy to pay funeral expenses, we recommend reviewing the policy and confirming coverage with the provider, in advance if possible.

## Common Funeral Terminology

There are a lot of words and terms surrounding funeral service that can be unfamiliar. Listed below are a few terms that you might hear. If you hear a word or phrase that you need clarification on, please ask a member of our staff.

**Arrangement Conference** - A meeting between the family and the funeral director to gather information for the death certificate, explore options, plan the services, make selections, and finalize details.

**Casket** - A four-sided container used to hold the deceased for viewing and burial. Caskets are available in various materials, such as wood or metal, with hinged lids in one or two segments.

**Coffin** - A six-sided container with a wider head end and a narrower foot end, resembling the shape of the human body (anthropoidal), used to hold the deceased for viewing and burial. Typically only made of wood with a removable, unhinged lid. Used more commonly before the American Civil War.

**Cremation** - The process of reducing human remains to calcium compounds, such as bone, by means of intense heat and flame.

**Death Certificate (DCs)** - An official document issued by a government certifying a person's death. Often needed for legal, financial, and genealogical matters. A fee is charged by the State of Utah for certified copies of the Death Certificate.

**Direct Burial** - A simple burial option where the body is buried shortly after death, without embalming, public viewing, or any formal services.

**Direct Cremation** - A cremation that takes place without a formal viewing, ceremony, or embalming.

## Common Funeral Terminology, cont.

**Eulogy** - A speech given at the funeral or memorial service honoring the person that has died. It reflects on the person's life, character, and impact they had on others, often sharing personal stories or memories.

**Final Disposition** - The final handling of a deceased person's remains, including burial or interment, entombment, inurnment, or scattering. Cremation is not a method of final disposition, but a preparation for final disposition.

**Funeral Director** - In Utah, an individual who has earned a college degree in mortuary science, passed national and state proficiency exams, and maintains licensure through the state to provide funeral services. Funeral Directors arrange, direct, and oversee funeral services in compliance with state laws, federal regulations, and local requirements.

**Funeral Merchandise** - The tangible items provided by the mortuary in connection with the disposition of human remains (e.g. casket, outer burial container, urn, keepsakes, clothing, printed materials, etc.).

**Funeral Service** - A structured service with the physical body of the decedent present at the service, which may include religious or cultural rituals.

**Graveside Service** - A brief service held at the cemetery.

**Interment** - The act of final disposition by burying human remains or placing them in an above ground crypt, mausoleum, or vault.

**Internment** - The confinement or imprisonment of people, often in large groups, typically during wartime. This is not related to funeral or burial practices, but is an often misused term and confused with interment.

**Inurnment** - The placement of cremated remains into an urn or the act of placing the cremated remains in the urn into the ground, a burial plot, or a niche.

**Memorial Service** - A service held to honor the deceased when the body is not present. Cremated remains can be present.

**Obituary** - A written notice of a person's death, published online or in a newspaper. Includes the person's full legal name, age, date of birth, date of death, brief biographical information, accomplishments, surviving family members, and details about services. When published, an obituary is a legal document.

**Opening and Closing (O/C)** - The digging and refilling of a grave, or preparing and sealing a crypt or niche.

**Outer Burial Container** - A vault or grave liner used to support the earth around the casket and prevent the ground from settling and collapsing the casket. A **vault** is designed to be sealed and prevent graveside elements such as moisture from entering the vault, while a **grave liner** primarily provides structural support.

**Pallbearer** - A person chosen to help carry the casket during the funeral service, typically from the funeral service to the hearse and from the hearse to the grave site. Often a close friend or family member of the deceased and serving in the role as a sign of honor and respect. Pallbearers do not have to be male to participate. An **Honorary Pallbearer** is recognized for their special relationship to the deceased, but does not physically carry the casket.

**Pre-Planning** - The process of making funeral arrangements for one's self in advance of death. This includes discussing and documenting a person's preferred services, merchandise, cash advance items, and disposition. Pre-planning allows individuals to make informed decisions ahead of time and helps relieve survivors from having to make such decisions after a death occurs. **Pre-Funding** the services can also be done during pre-planning to lessen financial burden on survivors. Funds are placed into an insurance policy or trust to protect them, and the prices of select options can be guaranteed against future inflation. Payment plans can be arranged with some insurance policies.

**Temporary Container** - A basic, non-decorative container used to hold cremated remains. Typically made out of plastic or cardboard and designed for short-term use.

**Urn** - A container designed to hold cremated remains, for long-term or permanent use.
