The District will consider and act upon the following matters:

4. To review, discuss and take action on the District's Investment Policy.
5. To review and act on financial matters, including financial reports, audits, investments, Investment Policy, and bills.
6. To receive a status update from strategic planning committee.
7. To receive a monthly report from Santa Fe Fire & Rescue, including authorizing payment of operations funding in accordance with the adopted budget and service agreement.
8. To review and approve a District False Alarm Policy.
9. To review and act on Ad Valorem tax exemptions for 2026.
10. To review and approve expenditures necessitated for the maintenance, upkeep, replacement, purchase, repairs and modification of real property, vehicles and equipment.
11. To review and act regarding capital acquisitions, including fire fighting vehicles/apparatus, ambulances, and emergency equipment and acquisition funding/financing for same.
12. To review and act on matters related to construction, renovation, repair, maintenance and improvements to District facilities and real property, including engagement of design professionals or engineering services, selection of builders/contractors, acquisition of materials for same, and cooperation with other county entities regarding the development of stations, including action on construction financing.
13. To meet in Closed Session under Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
14. To meet in Closed Session under Government Code §551.072 to deliberate regarding real estate.
15. To meet in Closed Session pursuant to Government Code §551.076 to deliberate regarding security devices or security audits.
16. To meet in Closed Session pursuant to Government Code §551.0761 to deliberate regarding critical infrastructure and cybersecurity matters.
17. To review and take any action regarding real estate, including sale, purchase, lease, platting, utilities, encumbrances, maintenance and legal actions related to real estate.
18. To set the regular meeting date for April 2026 and potential budget workshop or special meetings.
