We exist to

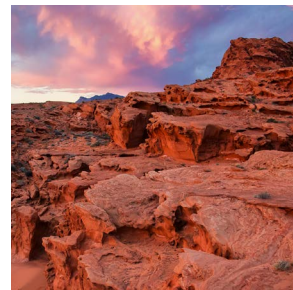

About National Conservation Lands

National Conservation Lands are between and beyond national parks, and are essential to clean air and water, sustained biodiversity, intact wildlife corridors and habitat, cultural continuity of Tribal Nations, hunting, fishing, and other outdoor recreational access, and strong local economies.

In 2000, Interior Secretary Bruce Babbitt saw that some of the West's last wild and culturally rich places were in need of care that would last. He helped establish the National Conservation Lands system (within the BLM) to preserve their natural values for the benefit and enjoyment of future generations.

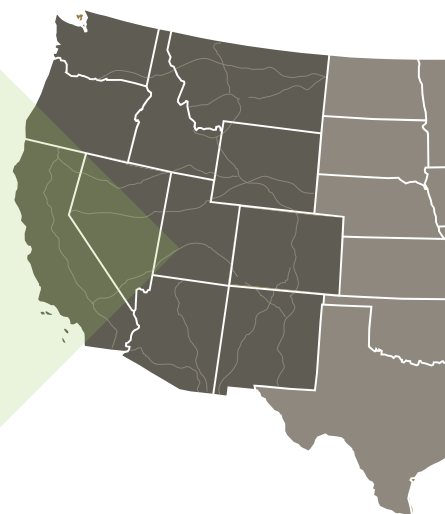

GROWING COMMUNITY LEADERS AND BUILDING POWER FOR PUBLIC LANDS

Our Friends Grassroots Network, or “Friends Network,” is made up of **84 local organizations across 12 western states**. We use two primary strategies to strengthen the ability of our Friends Network to be on-the-ground advocates for their local public lands: **Strengthening Organizational Effectiveness** and **Mobilizing Community Action**.

Strengthening Organizational Effectiveness

In 2025, through our Grassroots Advocacy Program, we helped these nonprofits stay resilient, strategic, and effective in their missions to protect public lands.

Executive Director Cohort

A four-month summer training for 17 new Friends Network leaders, with virtual sessions focused on organizational mission, strengths assessment, and strategic visioning.

Communications Cohort

Two interactive virtual sessions attended by 30 Friends Network members focused on sharpening social media strategies, strengthening storytelling, and boosting organizational visibility and impact.

Foundations of Conservation Leadership

This three-day in-person workshop brought together 11 new Friends Network employees for a crash course on fundraising, policy, advocacy, and justice, helping them build a solid foundation for their developing careers in conservation.

COLLABORATION: We recently announced a more robust collaboration with Together Rising As An Environmental Community (TREC), the nation’s leading environmental nonprofit capacity building advisors, through which we will **expand organizational development offerings for the Friends Network and our own staff.**

FUNDER IMPACT: We partnered with Edison International to distribute \$706,000 across five California Friends Network organizations as year one of a three-year project specifically for wildfire mitigation, education, and restoration. **The timing was especially important, providing partners impacted by federal funding cuts with the ability to continue essential stewardship projects.**

The Conservation Lands Foundation harnesses the community power of the Friends Network into a potent force for securing and maintaining public land protections at the federal level.

In 2025, we applied our collective strength to fight against a new administration and anti-public lands Congress members who pursued an unrelenting onslaught of strategies to sell off and unravel protections for public lands overseen by the BLM.

The Conservation Lands Foundation and our California partners were instrumental in the January **designation of the Chuckwalla National Monument, protecting more than 620,000 acres** in southern California.

This work was made possible by support from partners including Mosaic, a national collaborative funder and field catalyst that boosts the collective power of climate, conservation, and environmental health and justice movements in the United States to achieve durable, population-scale wins.

FUNDING THE FRONTLINE

Our Friends Network groups are doing extraordinary work on multiple fronts in the face of consistent attacks. This year, we were able to provide*:

- **\$1,754,500** in one-year, multi-year, or rapid-response grants
- **\$706,000** in special restoration partnership grants through Edison International
- **\$119,500** to support direct costs including travel, lodging, and campaign materials

We seek to ensure there is a representative community of local supporters for National Conservation Lands, and are committed to centering justice and inclusion in our work.

THE MOMENT WE FACE

This year, Friends Network groups lost hundreds of thousands of dollars in BLM grant funding. They are now working with less resources to fill critical gaps left by fired or furloughed BLM staff, including:

- Monitoring visitor safety, maintain public facilities, and manage campgrounds
- Providing protection for sensitive historic and cultural sites
- Mobilizing volunteer crews for stewardship projects

Our staff offered timely resources and connections to experts to help these groups navigate emerging risks in 2025.

Moving forward, **increased financial resources are needed to empower our Friends Network to sustain their impact and resilience.**

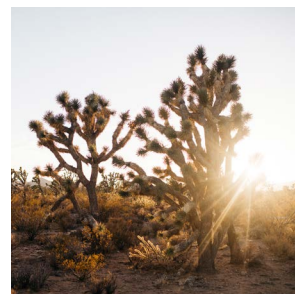

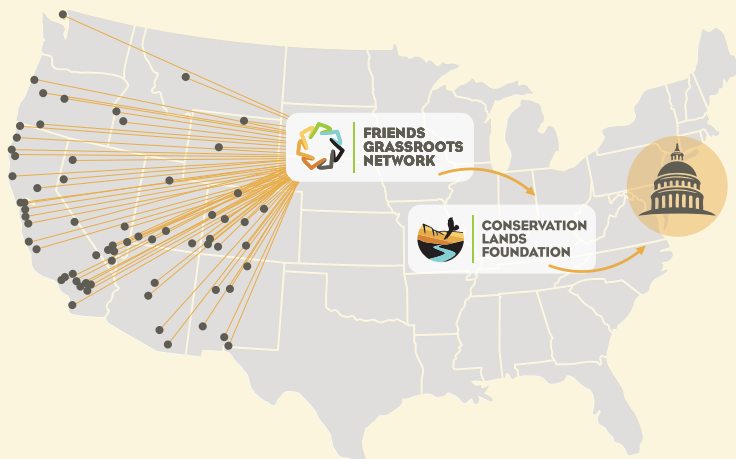

Local Voices, National Reach

Since 2007, we have secured **more than 11 million acres** of National Conservation Lands - a legacy achieved through direct presidential action, congressional legislation, and essential policy victories.

As our public lands now face existential threats, **the Friends Network remains the key driver of successful action.** Together, we will seek to uphold management standards, defend progress, and build the collective power needed for local to national conservation protections.

In 2025, We Responded To An Increased Need For Legal Defense of Public Lands

- Joined two Friends Network partners and six other organizations to **intervene in a lawsuit to defend the Chuckwalla National Monument**, following the lead of Ft. Yuma Quechan Indian Tribe, Torres Martinez Desert Cahuilla Indians, and three other Tribal Nations.
- **Offered and facilitated pro-bono legal advice** through Advocates for the West law firm for the Friends Network organizations to defend threatened national monuments around their communities.
- **Remain an intervenor** in four separate cases against the Public Lands Rule, and litigants in the original cases challenging boundary reductions of Bears Ears and Grand Staircase-Escalante National Monuments.

MAKING PUBLIC LAND PROTECTION A POLITICAL PRIORITY

The Conservation Lands Foundation engages directly with federal decision makers to secure and defend public land protections, and make conservation a political priority.

This year, we:

- **Supported the formation of the Bipartisan Public Lands Caucus in the House of Representatives**, a forum for both Republicans and Democrats to find common ground on public lands.
- **Joined the Senate Energy and Natural Resources Committee Public Lands Roundtable**, presenting alongside congressional allies on the importance of local input in decision making.
- **Led the effort to secure bipartisan congressional cosponsors** of the National Public Lands Day resolution.
- **Held our DC Fly-In**, bringing **11 Friends Network leaders** to Washington, DC to meet with more than 40 Democratic and Republican decision makers urging them to defend the Antiquities Act, prevent public land sell-offs, and adequately fund public lands.

SUCCESS ON THE GROUND

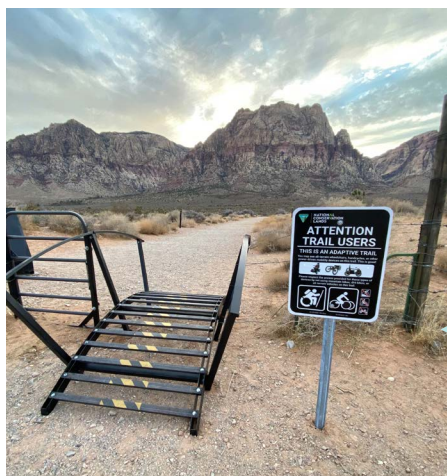
This year, we joined our partners to celebrate multiple wins resulting from years of CLF's dedicated funding to and support of our Friends Network.



In June, CLF and our Friends Network groups in New Mexico led **one of the largest rallies in the state's history**, with 2,000 attendees gathering in Santa Fe during Interior Secretary Burgum's visit.



We joined the Amah Mutsun Tribal Band, the BLM, and other local partners to celebrate the **opening of the Cotoni-Coast Dairies National Monument (CA)** to the public, previously accessible only through guided tours.



Trail Access Project, Friends of Red Rock Canyon, and the BLM installed **three adaptive trailhead gates** at Red Rock Canyon National Conservation Area (NV).

Through a grant from the Honey Hive Fund of the Tides Foundation, we led our **Arts & Advocacy Program**, designed to support women artists who want to become advocates for land protection and defense.

The Conservation Lands Foundation funded five artist projects across Arizona, Colorado, New Mexico, and Nevada, each centering local voices and public lands in need of protection.

ARTIST SPOTLIGHT

Jocelyn Catterson designed a project to introduce new viewpoints, explore values, and build community support for the protection of landscapes in the San Luis Valley (CO). Through intentional connections, she identified stories, visuals, and themes relating to the region. Those insights were transformed into seven poster-sized multimedia works that celebrate common ground, highlight shared values and honor the land.

Public Land Protection IS Climate Action

We partnered with Patagonia to host a widely attended public forum featuring a curated panel that highlighted the breadth and depth of support for public lands protection. Moderated by Chris Hill, speakers were Representative Melanie Stansbury (NM), Caroline Gleich (professional ski mountaineer and activist), Ryan Callaghan (President and CEO of Backcountry Hunters and Anglers), and Carleton Bowekaty (Zuni Tribe and Policy Director at Bears Ears Partnership). Together, they explored how everyone has a role to play in safeguarding our nation's natural resources, inspiring attendees to take action in their communities.

Where Story Meets Stewardship

The Parks Stewardship Forum is a peer-reviewed journal co-published by UC Berkeley and the George Wright Society that connects science, policy, and practice by featuring professional and community leaders in the stewardship space. We partnered with the Forum to publish an issue commemorating the 25th anniversary of National Conservation Lands. Authors include current and former BLM employees, members of our Friends Network, legal and policy experts, and CLF Board and Emeritus Board Members.

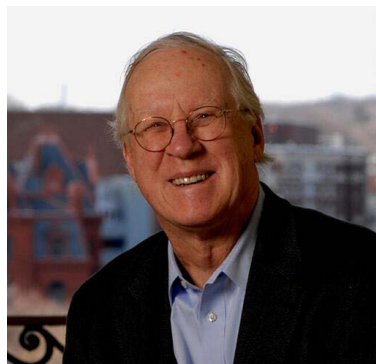

In Memory of Our Founding Visionary

RICHARD "DICK" MOE (1936 - 2025)

Richard Moe had a distinguished career in government, law, and historic preservation, and was a founding board member of the Conservation Lands Foundation. He served as Chief of Staff to Vice President Walter Mondale and as a senior advisor to President Carter.

Richard led the National Trust for Historic Preservation from 1993-2009, where he is credited with saving some of America's leading historical sites. He is the author of *The Last Full Measure: The Life and Death of the First Minnesota Volunteers* and *Roosevelt's Second Act: The Election of 1940 and the Politics of War*.

He was awarded the Vincent Scully Prize by the National Building Museum and Theodore Roosevelt-Woodrow Wilson Award from the American Historical Association.

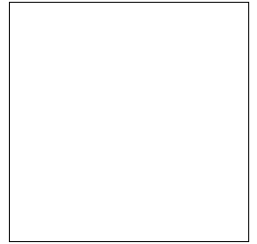
