This fee is for our basic services and overhead and will be added to the total cost of the funeral arrangements you select. (This fee is already in our charges for direct cremations, immediate burials, forwarding or receiving remains and packaged services.) This basic service fee includes charges for services we perform in conducting the arrangement conference, planning the funeral, securing the necessary permits, obtaining certificates, **local filing**, preparing the notices, coordinating the cemetery, crematory or other third-party arrangements, staff attention to funeral inquires, general clerical staff, holding room after remains are brought to mortuary, and use of mortuary paraphernalia.

If you want to arrange a Direct Cremation, you can use an Alternative Container. Alternative Containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are heavy cardboard.

Our charge for Direct Cremation (**without ceremony or viewing**) includes: local transfer of remains to the funeral home, services of the staff and obtaining permits, use of holding facilities (**after 72 hours** additional charges apply), use of vehicles, alternative cremation container, cremation and temporary urn (made of cardboard or plastic). The cremated remains will be ready for pick up at the funeral home by the next of kin in **10 business days**.
