

Privacy Policy

This Privacy Policy ("Policy") applies to www.ki-medicare.com, and The Kirscht Insurance Agency ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.ki-medicare.com and Bridlewood Insurance Services. The Company's website is a information site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name

We do not collect any personal information about you unless you voluntarily provide it to us.
