FAMILY STATEMENT

The McKee family acknowledges the providence of God in our success. We plan to remain privately owned, to continue to strive for growth, and to provide opportunities for those who work with us.

WHO WE ARE

McKee Foods is best known for its line of Little Debbie® baked goods. Little Debbie is America's leading snack cake brand in unit and dollar sales because we provide consumers with quality products of excellent value.

The company was founded in 1934 when a young couple, O.D. and Ruth McKee, bought Jack's Cookie Company, a small bakery in Chattanooga, Tenn., and started baking soft cookies and cakes. The business was known as McKee Baking Company from the 1950s until

1991, when the name was changed to McKee Foods Corporation.

McKee Foods was the first bakery to sell individually-wrapped cakes in a multipack carton. In 1960, the company introduced the Little Debbie brand and began selling the individually-wrapped cakes in multipack cartons. The product line was named after a granddaughter of the founders. A carton of 12 cakes and cookies had a suggested retail price of 49 cents at the time. Twelve products would have cost 60 cents if sold separately.

WHAT WE MAKE

Our largest brand is the Little Debbie® brand, with a wide range of favorites from Apple Pies to Zebra® Cakes. We also offer seasonal items, such as the Christmas Tree Cakes® product. Our products are sold in all 50 states and Mexico.



The Sunbelt Bakery® brand offers granola bars and soft baked bars, including products such as the classic Chewy Chocolate Chip Granola Bar. Unique seasonal flavors like Key Lime Pie delight consumers during the year and deliver on the brand promise of the Tastiest Flavors Under the Sun™!



Prairie City Bakery, founded in 1994, was acquired by McKee Foods in May 2019. The business is operated as a wholly-owned subsidiary



of McKee Foods and offers a wide variety of premium sweet baked goods. The products are distributed frozen through distributors, with the majority of retail sales in the convenience channel.



The Fieldstone® Bakery brand is a brand of cookies, breakfast pastries and other snacks targeted to meet the needs of the foodservice industry.

Drake's® cakes, founded in 1896, (acquired by McKee Foods in 2013) is made up of favorites such as the Devil Dogs®, Ring Dings®, Coffee Cakes, Funny Bones® and Yodels® products and other varieties sold primarily in the eastern United States.



HOW WE CONTRIBUTE

McKee Foods and Associates employs around 6,250 people corporate-wide.
