Bexar County Emergency Services District No. 11 (BCESD11) will conduct a Regular Board meeting at the BCESD11 Fire Facility located at 7412 Walzem Road, Converse, TX 78244 on May 15, 2025 beginning at 6:00 P.M. The following items will be discussed:

- 4. Bexar County ESD 11 Fire Chief's report regarding emergency operations, response times, call volume, training, management activities, purchases, personnel and authorizing appropriate action as necessary Chief Wendt
 - a. Run Report 228 runs for the month. Commissioner Stevens asked for clarification between Allegience called out and BCESD11 called out. Chief Wendt explained the difference in how each agency receives notice of a call. Commissioner Brown asked for clarification of 600 series on the run report. Chief Wendt these calls may not fit in a typical category. Some may be for trees down, or water leak. This is not work for a fire department to respond to. Chief Wendt is going to suggest to the County a 311 type of call center for these types of calls. Aerial is back in service. There was damage done to the cab during the service call and the vendor will take care of the expense to fix it. BCESDA is having an Expo on Friday, June 20 at the Freeman Coliseum. BCESD11 will take the tower and the brush truck. Commissioners are encouraged to go and receive the required credits. Staff participated in a 2-day class of the extrication tools. Next week there is a pre-survey ISO meeting with ESD10 & 12. Rope training with staff continues. Budget meetings with staff was very productive. ESD10 new chief starts Monday and Chief Wendt will reach out to meet with him. Commissioner Herrera asked about ESD1 and their contract that is going to expire. Chief Wendt explained that the costs associated with taking that area, even partially, is too great for dedicated costs of new apparatus, personnel, insurance, etc. ESD11 is still available for mutual aide.
 - b. Personnel Interviews for firefighter were conducted. There is a job offer that has been made.
 - Capital Purchases The public education tool has been ordered and about 6 weeks ETA.

Two new vendors are reporting for the first time during this period. There is new information that a Bath and Body Works is coming into the old Target building.
