Bexar County Emergency Services District No. 11 (BCESD11) will conduct a Priority Goal Setting Board meeting at the BCESD11 Fire Facility located at 7412 Walzem Road, San Antonio, TX 78244 on May 22, 2025 beginning at 12:00 P.M. The following items will be discussed:

- 2. Citizen Public Forum (3-minute time limit per individual) None
- 3. Presentation by Administrator Foster: Ms. Foster gave a review of last year's Goals Meeting and shared with the board that staff has done a tremendous job at meeting the goals. Fiscal Responsibility: Bills paid on time; increased reserve; responsible spending. Employee Retention: 3 employees have left employment with ESD11. We have increased the size of our staff and have a better response to job advertisements. Pro-Pay is currently in process. Training: Training has been a paramount focus of Chief Wendt. Staff were very pleased and grateful for the opportunities. Community Involvement: The addition of Santa Visit, Blood Drive, Public Relation/Education Program have been well received. Asset Replacement: Although a true Asset Replacement Program has not been adopted, the board continues to support the designation of funds toward future capital/replacement purchases. Growth: There is a desire to increase staff by two per shift bringing it to 12 per shift. Budget revenues dictate this growth. BCESD11 remains hopeful for more development and some legislation that would favor the ESD's.

This FY 2025/26, staff have identified the opportunity to make one-time purchases with additional revenue and cost savings of approximately \$500,000.

This FY 2025/26, staff is requesting a compensation study (approximately \$18,000) that will assess the competitiveness of ESD11's compensation structure. The study would also review the employee manual and job descriptions.

A marquis has been discussed previously. The current bids represent approximately \$50,000 in expense.

4. Presentation by Chief Wendt: Chief met with the Captains and Lieutenants regarding the budget process. Feedback was given from staff level of agreed upon recommendations to include in budget requests. Pay was heavily discussed. A training facility (approximately \$300,000). Add a position for an 8-5 Training Officer. A rescue trailer and supplies to participate with the East Side Rescue Team (approximately \$50,000). Squad Vehicle (approximately \$100,000). Continue with renovations at Station 140.
