  - a. Run Report 288 runs for the month. Summer is usually higher run counts. There were a couple of lightening strikes with no injuries. There have been a couple of structure fires. Met with ESD's that house Allegiance Units. We have identified some issues, and they are willing to work with us. The SAFE-D Expo downtown is next week. Currently working on a FEMA Grant for 3 positions that will end after 3 years. The Sheriff Department will begin their drone program trial soon in every ESD station. After the flood tragedy in San Antonio recently, the East Side Chiefs and special strike teams will work diligently to prepare for our area and help others in their areas. Chief met with the ISO Representative recently. Process has been streamlined. State First Responder License has been accredited again for another 2 years (2027). Update: Bexar County is updating to the US Digital.

the meetings that have taken place. Architects possess the knowledge a credentials to proceed. Architect is reasonable with their approach and appreciates the need to stay within budget. Executive Staff continue to include and accept feedback as to the needs to be considered through the process. Staff recommends the award of the contract for \$16,800 out of Construction Contingency. One restaurant in our district is temporarily closed. We will see the impact of that on our August deposit. They plan to re-open about the same time and expect to be larger and busier than ever. That will show in the October deposit. Bath and Body Works has started their signage in their store front located in the old Target building.
  - c. Discussion and action to approve monthly bills, invoices, and purchases for items included in the FY 2024/25 adopted budget for May 16 June 18, 2025. Motion made by Commissioner Stevens and 2<sup>nd</sup> by Commissioner Brown. Motion passes 5/0

Discussion and consider action of adopting a resolution regarding Budget Amendment BA2025-01 by increasing (decreasing) certain expenditures and increasing (decreasing) certain revenues to the individual budget accounts in all departments shown in Exhibit "A" attached. Ms. Foster reviewed the budget amendment with the board as these are anticipated overages that for the past 6 months, the board has voted on items that would require the budget amendment to settle the accounts.
