 - Health Code Violation from the town surrounding the status of the concession stand- this is township property and is not owned by us. A group of volunteers came out and this issue was resolved without further incident- A very special thank you to those of you that came out!
 - Football trailer breakin- On or about Dec 26th our football trailer was broken into- Tim and I learned of this incident on 1/7/2026 and took immediate action filing a police report that night. Given we can account for any missing items and there being a lack of surveillance in that area we want to be smart about what is stored in the trailers going forward.
 - Beginning the setup of the new site the comes with our new platform
- Spring Season will run from April 13th - May 15th
 - Goal is to have a clinical type spring season where both football and cheer will learn and gain valuable skills and tools to aid them in our fall season
