Landfill Fees:

All items have a \$10 minimum fee

Residential Drop-off Area: \$10 minimum or \$120 per ton

- **Garbage** (normal household waste)
- **Large Items** (furniture, toys, bikes, stoves, grills, washers, dryers)
- **Demolition/Construction** (wood, drywall, flooring, roofing, doors, windows, etc.)
- **Any small engine** must be drained of all fluids before drop off.

Processing Pad: \$10 minimum or a per ton fee

Landfill: \$15 fee and \$65 per ton

Mattresses: \$13+ weight

Freon Items: \$10 + weight
(refrigerator, freezer,
air conditioner, de-humidifier)

Brush/Clean Wood: \$36/ton
(wood that has not been painted,
stained, or treated).

credit/debit cards.
A fee will be added to use
credit/debit cards:

- \$1.95 on \$66.12 or less
- 2.95% on \$66.13 or more


Only people authorized by site attendants may utilize the landfill facility. You must provide your own labor for unloading materials. Due to safety concerns, we do not permit salvaging once waste is placed into containers.

PLEASE READ SIGNAGE

The Landfill's address is 3240 Berlin Drive. The diagram to the right illustrates the entrance to our facility (the landfill is the second right on Berlin Drive). The landfill entrance is equipped with inbound and outbound scales – **all landfill customers must scale in and out.** Department staff are available at the scale to direct you on disposal options and collection of payment.

For mailing, billing, and other departmental questions our office is located at 3200 Berlin Drive (first right on Berlin Drive) and parking is available on the south side of the building. We can also be reached at (608) 785-9572.

PLEASE NOTE:

- You must have a recycling card to use the Drop-Off site. To obtain a card, contact the Town Clerk or attendant.
- The Site is for the use of Town of Burns residents/taxpayers ONLY—not relatives or friends from outside the township. Do not risk losing your disposal privileges.
- If rules are not followed, citations will be issued according to the Recycling Code.

Yard Waste

Currently the town has no program for yard wastes and suggests that you compost your leaves and grass clippings on your property.

Recycling Fees and Instructions

- **FREE recycling of some items is offered:** Newspapers, glass jars and bottles, steel and aluminum cans, number #1, #2, (bottle form only) and #5 plastics, cardboard (no clam-shell to-go containers), paper cartons and newspapers are accepted. **NEW BEVERAGE PAPER CUPS. NO BAGGED ITEMS ARE ALLOWED** empty all bags into the bin. **NO SHREDDED PAPER**, even if bagged. See "How to Prepare Recyclables" page 3. Scrap metal items of a reasonable size are also accepted. Place demolition in the respective metal bin or large item dumpster/container.
- **Used tires:** Fee is \$7 for car/truck tires; \$20 for semi/tractor tires. Tires must be removed from rims prior to being accepted. Tires may also be recycled at La Crosse County's Household Hazardous Waste facility. See outside of brochure for more information.
- **Other materials:** The Town accepts small quantities of private demolition materials, furniture, carpeting, silo bags and other household items **only until that Dumpster is full.** (If it is full when you get there, please wait until the next Saturday.) Household appliances and electronic devices (E-waste) are accepted for recycling any time the solid waste recycling area is open. Fees are assessed for some of these items.

Special note on appliances: See light-green box in right column regarding appliance (white goods) disposal.

Special note on electronic devices: See blue box in the right column. See also the outside of this brochure for information on recycling these devices at La Crosse County's Household Hazardous Materials facility.

Mattress/Boxspring: Fee \$20

Hazardous materials: Cleaners, solvents, gasoline, oil, or other toxic, corrosive, explosive, or highly combustible materials may not be placed in the regular trash. Refer to the front page to see which hazardous materials are accepted at the La Crosse County Household Hazardous Materials Site. If in question, call the facility for a recommendation at 608-785-9999.

Special note on oil filters: By law they must be recycled. Take to the Household Hazardous Materials Facility (see box at right).

Light bulbs, dishes, glasses, mirrors, ceramics, jar covers, foil packaging are to be put into your regular garbage.


Open Burning

- **Burning barrels and brush piles:** No permit is required for burning barrels or brush piles. Before and when finished burning brush, call the La Crosse County Dispatch at 608-785-9634 and the Fire Chief at 606-498-8902.
- **Burning other clean materials:** A permit is required to burn clean materials (except brush). Burning permits can be obtained from the Chairman, the Supervisors or the Fire Chief (606-498-8902).

- **Campfire rings:** The fire must be contained in a manufactured freestanding fire pit, or ring placed at a safe distance from any structure or combustibles. Fire pits dug into the ground should be lined on the outside with gravel, brick, concrete, or rock to prevent the spread of flames across the ground.


Town of Burns Recycling & Solid Waste Drop-Off Site 2026 Schedule

The Town of Burns Drop-Off Site is for Town of Burns residents **ONLY**. You must have a garbage/recycling card (obtainable from the Town Clerk) to use the site. The site is for:

- **Household garbage**
- **Recycling materials:** Glass, steel and aluminum cans, #1, #2, #4 and #5 plastics, cardboard, paper cartons, and newspapers. See "How to Prepare Recyclables" below. **Please do not dispose of recyclables in regular household garbage.**
- **Appliances** (see fees on page 2)
- **E-waste** (see fees on page 2) **Note: Wisconsin law now REQUIRES recycling of electronic waste. It may not be disposed of in your household garbage.**
- **Tires** (see fees on page 2)
- **Oil filters and other materials** (see page 2)

Please see outside of brochure for information on disposing of hazardous materials and new styrofoam disposal information.

Household Hazardous Materials Facility (HHM)

Free for La Crosse County, WI residential users (unless otherwise noted below)

Fees apply to Houston County, MN and surrounding counties

Acceptable Materials

- Automotive fluids
- Batteries (rechargeable, lead acid, lithium)
- Cell phones and digital cameras
- Cleaning products
- Computers (desktops, laptops, tablets)
- Computer peripherals (fax machines, hard drives, keyboards, mice, printers, scanners, speakers)
- Fire extinguishers
- Fluorescent light bulbs
- Lawn and garden chemicals
- Medications (non-controlled only)
- Mercury-containing devices (barometers, thermometers, thermostats, etc.)
- Microwaves and small Freon appliances **Fees Apply**
- Paints, stains, varnish and solvents
- Pool chemicals
- Propane cylinders (20lbs and under)
- Sharps and needles
- Smoke detectors
- Solar Panels (A, B and C)
- TVs and computer monitors **Fees Apply**
- Vape pens/E-cigarettes
- Video devices (cable and satellite receivers, DVD players, gaming consoles, VCRs, etc.)
- Water filters (Point of Contact)

Non-Acceptable Materials

- Compressed gas cylinders (other than propane)
- Controlled substance medications
- Drums (single containers over 30 gal.)
- Explosives (inc. black powder, fireworks, military munitions, and flares)
- Shock sensitive materials (picric acid, etc.)
- Radioactive materials

SAVE YOURSELF A TRIP!

These items can and should go into your regular curbside trash or recycling:

- Alkaline batteries (trash)
- Dried out paint (trash)
- Empty paint and aerosol cans (recycle)
- Fertilizer without pesticide (trash)
- Ice melt and rock salt (trash)
- Incandescent light bulbs (trash)



Preparation & Transportation

Residential Drop-Off Hours

Monday – Friday (year-round): 8:00 a.m. – 4:00 p.m.

1st and 3rd Saturdays (April – October): 9:00 a.m. – Noon

Businesses and organizations by appointment only.

Fees apply by weight to all items for residents who live outside of La Crosse County. There is a \$10 minimum for each transaction.

FREE PRODUCT REUSE ROOM!

WE'VE MOVED!

Over 80,000 pounds of useable household products are sorted and made available to the public in our Reuse Room annually. All items are free, but donations are appreciated. The Reuse Room is open Monday – Friday from 8 AM to 4 PM. The reuse room is located on the south side of the building directly adjacent to the HHM Facility. Parking available at the entrance.

Safe Transportation of Hazardous Materials

- Never mix chemicals.
- Bring items in original containers or clearly mark contents. Tell facility technician if you are unsure what is in a container.
- Tighten all covers and lids.
- If a container is leaking, pack it separately in a leak-proof pail or tub.
- Avoid spills. Place waste containers upright and place securely in the trunk or back of a truck or van. Do not transport waste containers in vehicle passenger areas.
- Gasoline should be transported in a designated red safety container.



Sharps & Needles

- Needles, syringes, auto-injectors (EpiPens) and lancets must be transported in sealed, puncture-resistant containers.
- Container options include a standard red sharps container or a thick plastic laundry detergent bottle with screw on cap. All containers must be labeled with the word **“SHARPS.”**
- Additional sharps collection sites can be found on the Alliance to HEAL website. www.alliancetoheal.com
- For after-hours service, a red sharps drop box is located on Berlin Drive at the La Crosse County Solid Waste Department entrance. This drop box accepts single-use needles as well as small sharps containers. (see map above)
