### Rules and Regulations

*10701 Yellowstone Road, Cheyenne, Wyoming 82009*

- A maximum speed limit of 15 miles per hour within the Cemetery Grounds is strictly enforced to ensure visitors and employees' safety.
- All vehicles are required to stay on designated roadways within the Cemetery. Violator's will be held financially responsible for any damage to property.
- Pets must be kept on leashes and Pet Owners must pick up after their pets. Failure to do so may result in revoking the Pet Owners permission to bring pets on the premises.
- Fresh cut flowers, decorations, flags, statues, and vigil lights are permitted year- round.
- During mowing season, typically April 15<sup>th</sup> through October 15<sup>th</sup>, all items will be removed every Wednesday morning and disposed of to facilitate mowing operations. NO EXCEPTIONS.
- National and Federally observed holiday decorations are permitted one week prior to the holiday and must be removed one week following the holiday.
- Christmas Wreaths are allowed to be placed on gravesites as early as December 15<sup>th</sup> and should be removed no later than January 15<sup>th</sup>.
- The Cemetery reserves the right to remove and dispose of all items left after the specified time frame.
- Cemetery trees, shrubs, fencing, buildings, and other property should not be decorated with any ornaments, chimes, or lights of any kind at any time, and will be removed without notice.
- The cemetery assumes no responsibility for items left on grave sites.
- Due to the open nature of the grounds, we cannot guarantee against theft, vandalism, damage, and the effects of nature and assume no responsibility for monuments and decorations.

## What to Expect

### The process after your loved one passes

1. Please do not make any arrangements with your family or church, prior to visiting with a funeral director. This will ensure feasibility and availability of the funeral home staff, state agencies and cemeteries. The funeral home will contact and confirm availability for both the venue and anyone who has an active role in the services.
2. The Social Security Administration will be notified at the time of passing by Laramie County Vital Records.
3. You will meet with a funeral director, to make arrangements for services and sign documents.
4. If your loved was a veteran, you will need to provide the funeral home with a DD214.
5. Please bring Medicaid number, your loved one's parents legal names (including mother's maiden name), and your loved one's date and place of birth.
6. Clothing for your loved one will need to be at the funeral home 3 days prior to services.
7. If you would like to have flowers at the service, it will be your obligation to contact a florist to pick out and pay for your arrangements ahead of time.
8. Please do not hesitate to call, with any questions or requests, we are here to help you every step of the way.

This charge includes basic services of funeral director and staff, other preparation of the body, sheltering of the remains, transfer of remains to mortuary, service vehicle to the local cemetery. This charge does not include any type of services/rites in Cheyenne, merchandise, or cash advance Items.

#### **DIRECT CREMATIONS**

This charge includes basic services of funeral director and staff, sheltering of the remains, medical devise removal, transfer of remains to the funeral home within Laramie County, and our crematory charge. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials (with or without and outside covering). The containers we provide are heavy cardboard.

#### **FORWARDING REMAINS TO ANOTHER FUNERAL FIRM..... \$ 2,995**

This charge includes basic services of funeral director and staff, embalming, other preparation of the body, transfer of remains to the mortuary within Laramie County, obtaining necessary permits and authorizations, and a service vehicle, as well as transportation to Denver International Airport. This charge does not include any type of services/rites in Cheyenne, merchandise, or cash advance Items.

#### **RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME..... \$2,195**

This charge includes basic services of funeral director and staff, sheltering of remains, viewing, transfer of remains to the funeral home within Laramie County, hearse, and mileage to Denver International Airport. This charge does not include any type of services/rites in Cheyenne, merchandise, or cash advance Items.

## ITEMIZED SELECTIONS

However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$ 1,795**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charge for direct cremation, immediate burials and forwarding and receiving remains. Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; shelter of remains; planning of funeral arrangements; and coordination with those providing other services outside the funeral home as required. Also, included in these charges are overhead expenses relative to our facilities, such as professional licensing, legal and accounting fees, insurance, maintenance and utility expenses, taxes, secretarial and administrative costs, and equipment and inventory costs. *(Please note, this fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving of remains.)*

### **EMBALMING.....\$ 795**

Except in special cases, embalming is not required by law. Embalming may be necessary, however, if you select funeral arrangements funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require embalming, such as direct cremation or immediate burial. The Wyoming Board of Funeral Service Practitioners defines embalming as, "the disinfecting, preparing or preserving for final disposition of dead human bodies...the use or application of chemical substances, fluids or gases on the body, or by the introduction of the same into the body by vascular or hypodermic injection or by direct introduction into organs or cavities." W.S. 33-16-502 (xiv)
