Manufactured in the USA subject to USFDA and ISO 13485:2003 control.

**5. Limitation of Liability** - The liability of ASC for any claim arising out of or in connection with a breach of warranty or any other claim relating to the ASC product shall not exceed the amount paid to ASC by purchaser with respect to the sale of the specific product or products cited in such claim.
