Yacht Club/Sport Club Trailers, warrants each new Yacht Club/Sport Club Trailer to be free from defects In materials and workmanship for a period of two (2) years from date of purchase. Yacht Club/Sport Club Trailers shall repair or replace without charge, any parts found to be defective because of imperfect workmanship or materials, within a reasonable time after the trailer is returned at purchaser's expense to any Yacht Club/Sport Club Trailers authorized distributor or dealer.

**This Warranty is extended to the original purchaser only and does not extend to any other persons to whom the trailer may be transferred.**

**WHAT IS NOT COVERED:**

Provisions of this Warranty shall not apply to any product which is found to have been modified or altered in any way; nor shall the warranty apply to any defect or malfunction which was caused by damage, unreasonable use or failure to provide reasonable and necessary maintenance. The Warranty will not cover damage caused by overloading the trailer beyond stated capacities, the use of improperly installed weight distribution hitches in conjunction with hydraulic surge brakes. Due to the highly corrosive conditions a trailer is exposed to, rust formation *is not covered*. Our cost effective galvanized trailer is recommended for use in salt water. **This warranty does not cover:** winches, lights, couplers, brakes, tongue jacks, springs, and tires or wheels, as these items are warranted separately by their manufacturers.

**How Do You Get Service:**

Original purchaser must notify selling dealer of any defects in material or workmanship immediately upon discovery of the defect. It is the selling dealer's responsibility to notify the manufacturer of any warrantable issues and to request authorization and replacement warranty parts. For any warranty claim found to be valid, Manufacturer at its election shall either repair or replace the Trailer/Product or give the purchaser a refund of the purchase price. This shall be the purchaser's sole remedy. The dealer/purchaser is required to complete the warranty registration within (30) thirty days of purchasing the Trailer/Product for which warranty coverage is being sought to obtain warranty service. **THIS LIMITED WARRANTY WILL NOT APPLY IF A COMPLETE WARRANTY REGISTRATION IS NOT ON FILE WITH MANUFACTURER.**

**OTHER LIMITATIONS:**

**ANY IMPLIED WARRANTIES, OBLIGATIONS OR LIABILITIES, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY, SHALL BE LIMITED IN DURATION TO THE TWO-YEAR DURATION OF THIS WRITTEN LIMITED WARRANTY.** Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

The use of any unit as part of a rental fleet, or used for commercial purposes, voids this warranty. The following are exclusions of Yacht Club/Sport Club Trailers warranty: Loss or time, Inconvenience, towing charges, travel expenses, lodging, telephone, gas, loss or damages to personal property or loss of wages. This warranty is intended to comply with the "Magnusson-Moss Warranty Federal Trade Commission Improvement Act" and any provisions of this warranty or actions taken by Yacht Club/Sport Club Trailers pursuant to this warranty shall be construed accordingly.

HTC GROUP LIMITED, SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF THIS, OR ANY OTHER WARRANTY, EXPRESS OR IMPLIED. Some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
