

FORWARDING REMAINS TO ANOTHER FUNERAL HOME

This package charge includes the basic services of the funeral director and staff, local (within 10 miles) unassisted transfer of the remains to this funeral home, basic sheltering of the remains, sanitary care, obtaining all necessary permits and authorizations and, transfer of the remains to the common carrier (within 20 miles). This charge does not include a casket, alternative or shipping container. Nor does it include the use of the funeral home facilities and/or staff for any visitation or ceremony, public or private, prior to the forwarding of the remains, or any other sheltering for days on which no post-death activities occur. This charge also does not include any charges of the common carrier, or anything not expressly stated as being provided.

DIRECT CREMATION

Our package charge for direct cremation includes the basic services of the funeral director and staff, local (within 10 miles), unassisted transfer of the remains to this funeral home, basic sheltering of the remains for up to 48 hours, obtaining all necessary permits and authorizations and, local transportation (within 30 miles) to the crematory. This charge does not include the removal of battery implanted devices nor does it include the use of the funeral home facilities and/or staff for any visitation or ceremony, public or private, prior to the cremation of the remains, or any other sheltering for days on which no post-death activities occur. It also does not include the actual cost of the cremation process, which is a crematory charge, or anything not expressly stated as being provided.

If you wish to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are of corrugated cardboard material with a wood base.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME

This package charge includes receiving the remains from the other funeral home, transferring the remains from the common carrier (within 20 miles), the basic services of the funeral director and staff, basic sheltering of the remains, obtaining all necessary permits and authorizations and, local (within 10 miles) transportation to the cemetery or crematory. This charge does not include a casket or any other merchandise. Nor does it include the use of the funeral home facilities and/or staff for any visitation or ceremony, public or private, prior to the forwarding of the remains, or any other sheltering for days on which no post-death activities occur. This charge also does not include any charges of the common carrier, or anything not expressly stated as being provided.

IMMEDIATE BURIAL

Our package charge for immediate burial includes the basic services of the funeral director and staff, local (within 10 miles) unassisted transfer of the remains to this funeral home, basic sheltering of the remains, standard sanitary care and preparation of the remains for identification, obtaining all necessary permits and authorizations and, local transportation (within 10 miles) to the cemetery. This charge does not include the use of the funeral home facilities and/or staff for any visitation or ceremony, public or private, prior to the burial of the remains, or any other sheltering for days on which no post-death activities occur. Nor does it include the actual cost of the grave at the cemetery, or the cemetery's charges) for opening and closing the grave, any required outer burial container or cash disbursements, or anything not expressly stated as being provided.

BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF

Our fee for the basic services of the funeral director and staff includes, but is not limited to:

1. Responding to the initial request for service
2. Conducting the arrangement conference
3. Preparation of biographical and statistical data
4. Examination of financial settlement options
5. Preparation and filing of necessary papers, permits and authorizations
6. Coordination with other service providers
7. Preparation and placement of the obituary notices
8. Retention and care of the remains prior to the commencement of post death activities

This fee for our basic services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

EMBALMING

(Including use of the preparation room and sanitary care)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

New Jersey law (N.J.A.C. 8:9-1.1) provides that “no human remains may remain unburied or uncremated for more than 48 hours unless embalmed or refrigerated.”
