1. Insurance

Insurance is required for participation in Gymspire & Cheerspire classes, including training and competitions.

Insurance is NOT required for Roll & Play, Parent & Toddler, or School Clubs.

The group insurance fee is charged on joining and is prorated based on joining month.

The 2025/26 insurance fee is £12.50 per gymnast. Insurance fees are non-refundable.

2. Safety Rules

Participation in gymnastics and cheer activities carries a risk of injury.

Parents/Guardians consent to participation and agree not to hold Gymspire Academy liable for injuries or damages during activities.

Members must follow safety instructions, wear appropriate attire, and remove jewellery.

Medical conditions affecting participation must be disclosed on your parent account.

Gymspire Academy reserves the right to refuse entry if safety is compromised.

3. Arrival and Pick-Up

Children must arrive on time and not earlier than scheduled class time.

Children must be collected promptly.

Late collection beyond 10 minutes may result in additional charges.

4. Competitive Programme (Squad)

Competitive members must uphold Gymspire Academy values.

Members may not compete for other clubs.

Minimum training requirement is 2.5 hours per week with Gymspire Academy.

Attendance at designated competitions is mandatory.

Training kit and competition uniform must be purchased on joining. This can be purchased from your customer portal in the 'shop'.

Failure to comply may result in removal from the programme.

5. Competitive Cheerleading

Competitive members must uphold Gymspire Academy values.

Members must commit to ALL competitions & Showcases throughout the season unless agreed otherwise with the Head Coach.

Competition uniform, competition fees and the music & Membership fee are ALL non-refundable.

If a class is impacted by a bank holiday, this class will be rescheduled on an alternative day ideally in the same week.

Attendance is required on all weeks as this is a team sport. Non-attendance will affect the training for the whole team.

Cheer shoes (black) must be worn during competitions and training. These must be kept as indoor shoes only.

6. Events (Opt-Out Basis)

Certain events may operate on an opt-out basis.

By joining Gymspire Academy, you agree that your child may be automatically included unless you opt out.

Full details and deadlines will always be communicated in advance.

Parents/Guardians may opt out of an event by the stated deadline.

If no opt-out notice is received by the agreed date, any associated charges will still be charged and are non-refundable.

7. Cancelled Classes Outside of Gymspire's Control

Classes may be cancelled due to circumstances beyond control such as school closures or severe weather.

Make-up classes will be offered **where possible but not guaranteed**.

Refunds/credits will not be issued where cancellation is beyond Gymspire Academy's control.

8. Trials, Enrolment and Cancellation

Free trials are available for Academy classes (excluding cheer try-outs).

Enrolment is automatic unless cancelled within 24 hours after trial.

30 days' notice is required for cancellation via Parent Portal.

Fees remain payable until formal notice is received.

9. Non-Attendance Due to Injury

Injury must be reported immediately with medical confirmation.

Fees may be adjusted for up to 6 weeks.

If Gymspire Academy are not informed, then we cannot be accountable for any potential fee adjustment. This will not be backdated.

10. Holiday Camps & Workshops

Rescheduling permitted up to 48 hours prior.

Payments are non-refundable and non-creditable once made.

11. Goods We Sell

Third-party goods may be exchanged if unworn and in saleable condition.

Returns not accepted where washing instructions were not followed.

Merchandise must be hand washed only with NO fabric conditioner.

The expectation is a leotard should only be washed rarely when needed.

12. Our Responsibilities and Limits of Liability

Coach allocation cannot be guaranteed.

Appropriate verbal discipline may be used for safety.

Physical contact may be necessary for coaching and injury prevention.

Gymspire Academy is not responsible for lost or stolen items.

Anti-bullying and equality policies are enforced.
