All persons making funeral arrangements are entitled to a copy of the "Consumer Guide to Funeral & Cemetery Purchases" from the California State Department of Consumer Affairs prior to drafting for funeral services. A copy of this guide will be provided to you, it is also available on the internet at www.dca.ca.gov/cemetery.

TERMS OF PAYMENT

1. Professional Services:

Basic Service of Funeral Director, Staff, and Overhead..... \$325.00

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations.)
