Sandy Terraces is a Co-Operative campground. That means each and every member is expected help run the camp and be an active member. Membership will be reviewed on a yearly basis for following year.

Full members, after paying all and appropriate fees are entitled to have a camper/r.v. on a site. They are expected to perform gate duty and other tasks as needed throughout the camp. See all rules and regulations regarding what is expected.

Associate Membership Fees: Single-\$250.00 / Couple: \$ 350.00

All associate members have unlimited 9 AM-6 PM access to the camp. They are expected to participate in opening clean up weekends as well as close down weekend.

They may attend camp meetings (2 times a season) but may not vote. Any after 6PM participation must be approved by the director or his/her designee. They must be familiar with and follow the same rules and regulations as a full-time member.

Full Time Membership Fees: Single-\$300.00 / Couple-\$570.00

Full time member fees include membership in AANR yearly. **Associate membership will be reviewed on a yearly basis for following year. Associate membership is not automatic.** R/V sites may be available to full time members.

Sandy Terraces Associates Waiver & Release of Liability Form

In consideration for being permitted by Sandy Terraces Associates, and their members, directors, officers, agents, and assigns (hereinafter "STA") to participate in any level of membership, including visiting/camping and all other campground activities or otherwise being present on the property (hereinafter "membership"), I hereby waive, release and discharge any and all claims for damages for personal injury, death or property damage which I may have, or which may hereafter accrue to me, as a result of my membership. This agreement covers all areas and facilities owned by or connected with STA, including but not limited to the pond, pool, parking facilities, picnic areas, campground, common areas, member sites, RV sites, restrooms, offices, and showers. This release is intended to discharge in advance STA from any and all liability arising out of or connected in any way with my membership, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

It is understood that this activity involves an element of risk and danger of accidents and knowing those risks, I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold STA or entities free and harmless from any loss, liability, damage, cost or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in membership.

I have read this Release of Liability and Waiver Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I understand the failure to comply with the camp rules may result in my immediate expulsion from Sandy Terraces.
