2 Minutes of the last meeting– Monday 16th June 2025 – these were agreed unanimously and signed as a true record, then signed by the Chairman

- **5. Somerset Community Award Nomination –** it was agreed unanimously to nominate Mrs Carla Searle for her 10 years sterling work for the community as a serving Parish Councillor
- **6. Agree fencing quotes for Joseph's Pound –** after obtaining 3 quotes, it was agreed that the contractor Morgan's quote was accepted. This is dependent on the mid-September deadline
- 7. State of goal posts/nets at play park Cllr Wall had put new cable ties to hold the nets to the crossbar. Cllrs to inspect them and clean the goal posts following their park inspection
- **8. Quotes to cut brambles rhyne side of the play park** since this was placed on the agenda, the contractor had cut the grass, so Cllr's to check if the brambles had been trimmed
- 9. Old Bristol Road update the PC had written to the environment agency, planning officer and Unitary Cllrs expressing their concern over the quarry stone crushing activity at the site. Despite speaking to the planning officer, informing them again of the concerns, nothing has been reported back. Unitary Cllr Filmer to escalate this at Somerset Council
- **10. Rookery Close update** the Chairman, Cllrs Broderick, Wall and Gilling, along with the Clerk, had a meeting with Homes in Somerset re the feasibility of this particular site. It was agreed that Homes in Somerset to make arrange a public consultation, along with the PC for early September 2025. This would be advertised so as many of the public can attend

Matters of Report

Cllr Champion – stated that the meeting with the Chairman, Cllr Filmer re the planned new opening onto Hill Lane on Mr Hancock's land would be beneficial to the traffic entering/exiting with the hedge cut back Unitary Cllr Filmer – There is to be a Pay & Grading Review following the creation of the Unitary Authority in 2023. External consultants to carry out the review over the next couple of years. Some of the new parking charges proposals have been delayed, awaiting results from the consultation. The new boundary review is still available for comments to be made up to August 11th 2025.
