- **5. Defibrillator Training** the Clerk to contact Community Heartbeat to ask for a training refresher, not only of how to use the Defibrillators, but the maintenance of them as well
- 6. Somerset Community Award Nomination it was agreed to defer this to the July meeting
- 7. Agree fencing quotes for Joseph's Pound Cllr Wall had only received one quote back from suppliers, so it was agreed that once the other quotes had been submitted, to discuss at the next meeting
- 8. Parish Council interviews the Clerk to arrange interviews to take place as soon as possible

## **Matters of Report**

Clir Carter – informed the meeting that the new Vicar who had expressed an interest in becoming our Vicar has now withdrawn their application. The process to find a new Vicar will now start all over again Clir Champion – had been talking to Mr Hancock regarding his proposal of the opening to his land off Hill Lane. The Clerk to arrange a meeting to discuss as soon as possible Clir D Dover – stated that the dog loo bin in the Cemetery is broken (someone has stolen the lid!) It is always full, despite being emptied a couple of days prior. To that extent, the Clerk to write to Clean surroundings to enquire about a larger bin and the cost of installation and emptying costs Unitary Clir Filmer – informed the meeting that Somerset Council must find £101 million in savings for the next financial year to balance its budget. A new interim Chief Finance Officer (third one in under a year). There is to be a Pay & Grading Review following the creation of the Unitary Authority in 2023. External consultants to carry out the review at a cost of £3 million

**Clir Broderick** – stated that the solar panels have not been installed correctly due to the incorrect inverter being used and the bird guard had not been fitted. A complete re wire of the Hall is to be carried out, and quotes are being sought. The VE/VJ event was a huge success with many people attending. **Clir Gilling** – informed the meeting that the long-awaited 2<sup>nd</sup> reservoir at Cheddar has now been given the go ahead. The damaged wall on Pill Road has still not been repaired. He has written to Highways asking for the work escalated bearing in mind the time it has taken

**Clir Wall** – stated that there is a bench in the Cemetery which is in need of repair, along with a tree that needs to be topped. The Clerk to contact our contractor to make good.

**Clerk –** had received an email from Homes in Sedgemoor asking for a PC consultation re a possible development of land in Rooksbridge for affordable houses. The Clerk to set up a meeting as soon as possible.

**Chairman –** asked the Clerk to write to Somerset Council to see if the play equipment opposite Red House Road is still being testing by Somerset Council

It has been brought to the Parish Council's attention, that despite signage placed at the entrance and within the East Brent Play area, DOGS ARE STILL BEING exercised off the lead. Dog faeces are being left which is a Health & Safety issue, with children using the football nets extensively. The Parish Council is asking ALL dog owners to adhere to the signs please
