2 Minutes of the last meeting– Monday 1<sup>st</sup> September 2025 - these were agreed unanimously and signed as a true record, then signed by the Chairman

- 7. Finalise new bench (Colin Loader) it was agreed that a new for seater bench made from recycled plastic bottles to be ordered. The Clerk to order and sort the installation date with Cllr Wall
- 8. Financial update YTD (April/Sept) budget discussion the Clerk distributed the financial print outs of the budget/YTD for the period April/September. He explained how the report works, and asked for some feedback at the November meeting. In the meantime, the Clerk will now start to look into the new precept budgets for 2026/27
- 9. **Nuttall Trust Update** the Nuttall Trust is a Charity which can provide financial support for local or individual projects, community organisations and clubs that are based in our Parish (also other local Parishes). The Clerk asked Cllrs for any ideas of organisations which may benefit from the grant and report back at the November meeting

## **Matters of Report**

**Clir Carter –** informed the meeting that the position of a new Vicar is to be advertised again, with a closing date of end November 2025

**Unitary Clir Filmer –** gave an update on what is happening at Somerset Council. A consultancy company has been appointed to identify over £100 million of saving's for 2026/27, rising to £190 million by 2029/30. The planning service recovery, set up to reduce planning applications will now be referred to the Climate & Place Scrutiny at the end of October. There is a public consultation re a proposal to introduce Sunday charges in all of our car parks. **Clir Gilling** – concerned about the length of time it is taking to repair the bridge in Rooksbridge. He has now been told that work will commence the end of October

**Clir Wall** – expressed his thanks to J Bethall regarding to the excellent work they did renewing the fencing at Joseph's Pound. Various other items were asked for (footpaths/bench etc) and the Clerk to set up a site meeting to discuss what work can be undertaken

**Clerk –** informed the meeting, that at the recent Somerset Playing Field award ceremony, he was pleased to announce the Brent Road Park won a bronze award. Commendations were given to Joseph's Pound and Orchard Close play areas.

**Chairman** – stated that the state of the rhyne from Mendip to Pill Road needs to be looked at by the Drainage Board. A letter to be sent to the DB asking for them to report back to the Parish Council. Also, the state of surface of the road on Brent Road to the Knoll Inn needs to be actioned re filling in large pots holes, especially as a child injured themselves falling of their bike. The Chairman to log on the Highways Portal.
