## Terms of Payment:

We understand this is a difficult time, and our team works diligently to support families through every detail. To ensure arrangements proceed smoothly, payment in full is required within 48 hours of finalizing arrangements and prior to the scheduled service.

Orders for merchandise and additional services—including caskets, urns, catering, flowers, and printed materials—are placed upon receipt of payment. If payment is delayed, some items may not be available in time for the service.

### Acceptable forms of payment are:

- **Funded Funeral Prearrangement:** Many people choose to pay for a funeral in advance with a funded funeral prearrangement. Funeral Plans funded with an insurance policy, trust, or annuity are accepted.
- **Cash or Check:** Cash is always an acceptable payment option.
- **Bank Transfer:** This form of payment requires a bank account.
- **Credit Card:** All major credit cards accepted (Visa, Mastercard, AMEX, Discover).

## Refund Policy:

It is the policy of this funeral home to make refunds in full for any services or merchandise that have been canceled 48 hours or more in advance and not provided by this funeral home. Any services provided and any merchandise or third-party items already delivered for the service cannot be canceled or refunded.

*Living Stones are beautiful handmade memorial keepsakes that combine a small portion of a loved one's cremated remains with natural minerals in a unique process that results in a stunning smooth and durable stone. They are created by skilled artisans in state-of-the-art production studios in Colorado and Ohio, and the process takes approximately 45 days to complete. The portion of a loved one's cremains required is based on the number of stones created.*

## Basic Services of Funeral Director, Staff and Overhead

- Conducting the Arrangement Conference(s) with family or responsible party
- Planning and Supervising all details from the selected package (s)
- Preparation and Filing of Necessary Authorizations and Permits for final disposition
- Recording Vital Statistics
- Coordination with those providing other portions of the final disposition of the deceased, e.g. crematory, sheltering, postage, printing

Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, maintenance and utility expenses, secretarial and administrative costs, and compliance costs relating to state and federal regulations. This non-declinable fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations and immediate burial.
