Yashica Conley moved to approve the minutes of the Child Care Advisory Group meeting on April 8, 2025. The motion was seconded by LaQuita Crayton and passed with no opposition.

5. Consider and take appropriate action regarding update on Child Care Services: Rhonda McGrath

Rhonda McGrath gave an update on Child Care Services. They are not seeing any cuts with the Child Care Development Block Grant, which is the primary Federal Government funding source for Child Care Services in Texas. The Texas Workforce Commissioners (TWC) approved the 2026 East Texas childcare budget for \$34 million in direct care. Their target for children served this year was 5,700. As of this morning they had 6,030 children in care. There are two ladies in the position of Business Industry Support Analysis who started working with the childcare staff on July 1, 2025. They do not tell the childcare centers how to run their business but give them ideas and support. Through all their transactions there is job coaching with different classes. Thanks to the ladies and childcare staff, childcare no longer has capacity issues. The childcare staff will be getting a flyer out to all their providers on information about the free service and training.

Gary Allen briefly discussed property tax relief to centers needs for modification so centers/owners can receive the intended benefit. It is usually the larger cities which are eligible for the tax. Licensed homes qualify for tax relief, but registered homes do not qualify. It could reduce their property taxes to a minimum of 50% if passed before the city and county. The centers/owners need to analyze what the potential impact would be for childcare if a county entity is considering this benefit.

B. Education Savings Account (Vouchers) legislation impacting the Child Care business and possibilities for CCS (Rising Star) to implement a 5th star rating which would quality 4-star centers to qualify to accept voucher funds

Gary Allen discussed the Education Savings Account (Vouchers) legislation impacting the Child Care business and possibilities for CCS (Rising Star) to implement a 5th star rating which would

qualify 4-star centers to qualify to accept voucher funds. September 1, 2026, is when the vouchers can be turned in. It is for high school students, middle school students and all the way down to pre-K (childcare) students. The State Comptroller's Office is responsible for the implementation of this legislation. It is the responsibility of the Texas Comptroller of Public Accounts to put the mechanisms in place for individuals to apply for vouchers, families, and schools to be participants in the system. MJ Wagner stated if a program is a three or four star, in partnership with a school and meets other requirements, they qualify for the vouchers according to the bill. She added she has a meeting in Austin next week and is planning on bringing up the possibility of Texas Rising Star implementing a fifth star rating.

Gary Allen stated he would research any topics/issues which may come up. No one brought up any preliminary discussion of other Child Care topics/issues at this time.
