Doug Shryock welcomed everyone at the meeting and used a Child Care Advisory Group roster list for roll call. He asked everyone who attended both in person and virtually to give an introduction and a brief description of their duties and organizations.

4. *Consider and take appropriate action regarding an overview of the role of the Child Care Advisory Group: Chair Camille Brown and Doug Shryock (Enclosure #1)

Doug Shryock reviewed an overview of the role of the Child Care Advisory group enclosed in the Agenda Packet.

House Bill (HB) 619, 87th Texas Legislature, Regular Session (2021), added §302.0062 to the Texas Labor Code, requiring the Texas Workforce Commission (TWC) to prepare a child care workforce strategic plan for improving the quality of the infant, toddler, preschool, and school-age child care workforce in Texas. Based on the HB 619 requirements, TWC's three-member Commission approved the Child Care Workforce Strategic Plan 2023–2025 (Plan), which includes specific goals, strategies, and action plans for implementation. Action Item 3.2.2 in the Plan requires Workforce Development Boards (Workforce Solutions East Texas Board) to establish local child care committees (Advisory Groups).

The Chairman of the Workforce Solutions East Texas Board (WSETB) appoints members of the Child Care Advisory Group. The Group will offer the Workforce Solutions East Texas Board information, observations and recommendations they can use in their policy deliberations.

Appointees are considered based upon suggestions from partners such as the Child Care Services contractor and Texas Rising Star.

Chair Camille Brown provided a handout to review topics/issues to be addressed by the Child Care Advisory Group in the coming months.

- Subsidies providers shy away from accepting CCS because rates not high enough
- Property tax relief to centers needs to be modified so centers/owners can receive the intended benefit
- Key issues: staffing shortages, burnout, retaining, advocating for adequate funding for state childcare assistance, many child care businesses are at risk of closing unless more funding is put into the system
- Goal: overcoming obstacles as we continue to deliver exceptional care for children and their families now and well into the future. And that we as providers can help ensure early childhood education remains a "pillar of our communities"
- Education Savings Account Bills will impact the child care business (Vouchers) CCS (Rising Star) could implement a 5th star that would quality 4-star centers to qualify to accept voucher funds
- These issues are state problems not federal problems and can be fixed

The members encouraged more child care homes to participate in child care services (CCS) and not just the centers. They would also like to see more overnight centers opened.
