- Vendor spaces are 10x10. If any portion of your display exceeds these dimensions, additional space(s) **MUST** be purchased.
 - All vendors must supply their own electricity. Participants are responsible for bringing tables, chairs, tablecloths, display signs, tent weights, etc. Quiet generators (60 dB (decibels) or less) stationed on food trucks are permitted; **loud generators (71 dB (decibels) or more) are not permitted** for the comfort of our festivalgoers and other vendors. Food trucks and vendors with trailers must unhitch their trailers for this event and remove vehicles from the premises.
 - Set-up begins at 9:00 AM and concludes at 11:30 AM. You must unload and move your vehicle before setting up. All vehicles **MUST** be removed from the festival area by 11:00 AM.
 - The event ends at 6:00 PM; no items may be moved until after that time.
 - Damage or loss is the vendor's responsibility and not that of the Pocono Chamber of Commerce, the Borough of East Stroudsburg, or the Pickle Me Poconos Festival.
 - If a vendor is unable to attend the event, please contact Sierra Lefurgy by September 12th.
 - All vendors are responsible for trash removal. Any trash remaining will subject the vendor to a \$100 trash fee.
 - No-shows will be subject to a \$100 fee. This event is in high demand, and we need to be mindful of vendors we turn away.
 - The theme is Pickles! All vendors are **required** to feature at least one pickle-themed product.
 - **Insurance is required.** Proof must be submitted with application and payment with coverages as follows: All vendors must have general liability insurance and coverage shall not be less than \$1,000,000 per occurrence and \$2,000,000 in the aggregate. Commercial Auto Insurance minimum coverage of \$1,000,000 per occurrence for food truck vendors. Primary and Non-Contributory for scheduled Additional Insured. Waiver of Transfer of Rights of Recovery Against Others to Pocono Chamber of Commerce.

You will receive an **email** confirmation once your application is accepted. You will also receive an email approximately three to five days before the event with festival set-up instructions and details.

Attention Food Vendors: You will receive an email from the Health Officer of the East Stroudsburg Borough prior to the festival with instructions on providing proper documentation necessary to obtain the temporary license. This is a requirement to serve food at the festival on September 26th. For questions, please contact the Health Officer at 570-421-8300 x 105. **If you are a food truck, please contact Sierra Lefurgy directly at slefurgy@poconochamber.org or 610-295-9047 to secure your spot and solidify pricing.**

Attention Beverage Vendors: **No open containers of alcohol are permitted to be sold by general vendors at this event!** Open-container alcohol is permitted in the Beer Garden only and contracted by the Chamber directly. Closed bottles may be sold along with 5 oz free tastings of alcoholic beverages and you will be categorized as a beverage tasting vendor. Please note if you are a beverage vendor that prepares drinks on site (fresh fruit, pickles, etc.) you will need a temporary license and be considered a prepared food/beverage vendor.

Space/Location: We will be offering the opportunity to pay for a spot on Crystal/Washington Sts, the placement of which street is at the discretion of the Pocono Chamber of Commerce. This is first come first served, based on availability, and will be a one-time fee of \$100.00. Please indicate below if you would like to guarantee your premium location.

By submitting this application and remitting payment, you agree to the terms listed in this document.
