We can't wait to see you in October to celebrate Mardi Gras in San Marcos! Laissez les bons temps rouler!




Hello TAA Members!

Audiology Advocacy Day!

On March 1, 2023, a group of 16 audiology advocates descended upon our state capitol in Austin to meet with elected officials and use their audiology voice to talk about the future of our profession. Your Texas Academy of Audiology was represented by 14 AuD students (5 hailing from Lamar University, 2 from Texas Tech Health Sciences Center, and 3 from the University of Texas at Dallas), and 6 professionals coming from the DFW, Houston, and Austin metro areas. Because the Texas legislature is only in session for 6 months once every two years, it is critical for us to utilize this opportunity to put a spotlight on audiology. This was our third in-person advocacy trip since 2017 and the group has grown each year!

As a group, we had the opportunity to meet with the TAA lobbyist Brad Shields, Representative Julie Johnson (D-115) and Speaker of the House Rep. Dade Phelan (R-21). Everyone in the group had individual meetings with their elected officials throughout the day, and the students were even able to meet with Katie Bryce at the Texas Department of Licensing and Regulation. In total we connected with the offices of 20 legislators—a very busy day!

There are several bills up for consideration this year on topics including insurance, the audiology interstate compact, over-the-counter hearing aids, telehealth, and newborn hearing screenings. Our legislators need to hear our expert audiology voice to ensure they have the best information to make decisions that help our profession grow and our patients thrive. First-time advocate Lindsey Sanford of Lamar University said "If I had the opportunity to encourage someone who was on the fence, I would tell them to just do it. It might feel scary, or that you're going in to talk to someone about something you don't know much about, but nothing will get done if we don't do anything."

Out of 16 people, only four had any kind of prior experience with in-person advocacy. One theme of the day was simply how easy advocacy can be. We are the audiology experts, and there is no one better equipped to have a conversation about ears with policymakers who are paid to listen.

When asked how her experience from March 1st could help inspire other audiologists take the first step in their advocacy journey, Kelsey Spencer of Lamar University gave this advice: "If someone was on the fence about participating in advocacy, I would tell them to just go for it. Decide why they are an audiologist (or an AuD in training) and use that as a reason to spread the word and make the field a better place for them and those coming after." Dr. Sarah McAlexander of Texas Hearing Institute in Houston added: "I highly recommend that audiologists consider reaching out to their legislators and make their voices heard ... We all have knowledge and experience to share that will help make our state a great place to work and live. In a profession as small as audiology, every voice matters!"

The current 88th Texas Legislature is in session through May 29, 2023. Please use this link to determine your state representative and state senator. Take 3 minutes to call/write to them to let them know you are an audiologist in their district and ask for their support! 






Medicare Limited Direct Access Provisions for Audiology Services: What audiologists need to know, for now...

Introduction

On January 1, 2023, the Medicare Physician Fee Schedule officially established a new coverage benefit for audiology services. Prior to 2023, all Medicare-covered audiology services required (1) evidence that the procedures are medically necessary, and (2) a physician or other qualified non-physician practitioner (e.g., physician's assistant) order. Effective January 1, 2023, the Centers for Medicare and Medicaid Services (CMS) has instituted a limited direct access provision for select audiology services.

Background

This new limited direct access benefit category did not add or delete any covered services under Traditional Medicare Part B coverage policies. It utilizes a select list (subset) of Part B covered audiology services that can now be reimbursed without a physician or other qualified nonphysician practitioner order for non-acute hearing issues. The list of limited direct access codes can be found here: https://www.audiology.org/wpcontent/uploads/2022/11/coding-list-1-1.pdf.

It follows that any audiology services that are not on the audiology limited direct access list will still require a physician order and all covered services under Medicare continue to require support of medical necessity for the evaluation. Audiologists may continue as usual by obtaining an order for all Part B covered audiology services reimbursable through Medicare (see full list of codes for audiology services covered through Medicare here:

https://www.cms.gov/files/zip/audiology-codelist-updated-7522.zip).

Outlined below are the details of the audiology limited direct access provision under Medicare:

- Effective date: January 1, 2023
- Applies only to Medicare Part B claims and beneficiaries; does not apply to Medicare Advantage
- Provision includes a limited code set of 36 distinct audiology services
- Covered without an order from a physician or other qualified nonphysician practitioner
- Only for non-acute hearing issues (e.g., gradual loss of hearing, typically in both ears)
- Benefit can only be used 1x per patient per 12 months (no respect to calendar year)
- Report one or more of the available 36 CPT codes in the limited direct access code subset and append AB modifier to each to indicate it is under the limited direct access benefit
- Will take ~6 months for Medicare to operationalize (~June 2023)

Use of the new AB Modifier to indicate use of the new Audiology Limited Direct Access Provision

The AB modifier is a new modifier created for the purposes of tracking claims which use the new audiology limited direct access provision. The AB modifier should be appended to each code that is reported when practitioners are billing Medicare for covered Part B audiology services without an order. The AB modifier is not applicable for codes other than the 36 listed as part of the limited direct access provision. Frequency Limitations of the Audiology Limited Direct Access Provision

As mentioned earlier, Medicare Part B beneficiaries are now able to seek care directly with an audiologist for non-acute hearing issues without the need for a physician order. The frequency limitation for this provision is outlined as a one-time-per-year benefit. This yearly benefit renews every 12 months, irrespective of calendar year. For example, if you bill one or more CPT codes with the AB modifier on a certain date, none of the codes on the list of 36 applicable CPT codes will be payable under for another 12 months without an order.

Discussion of Unanswered Questions

<u>Program not yet fully operationalized through CMS</u>: Our contact with Medicare Administrative Contractors has resulted in current guidance to <u>not submit any more claims for audiology limited</u> <u>direct access until CMS finalizes the system</u> (expected Summer 2023). Claims processing systems have not yet been updated to handle the AB modifier and issues persist related to placing the audiologist NPI on the CMS 1500 claim form as the ordering provider. We will also discuss the use of the Advance Beneficiary Notification (ABN) below, as they relate to different parts of this new Medicare provision.

<u>Frequency Limitation:</u> CMS has yet to operationalize an online benefit checker. Thus, we are currently uncertain about whether the benefit has been exhausted for any and all beneficiaries seeking services under this new audiology limited direct access provision. Audiologists may hold their claims until the program is operationalized (recommended) or may consider using an Advance Beneficiary Notification (ABN) and appending the GA modifier to indicate that a mandatory ABN was administered. This would allow clinics to collect money from patients at the time of service while the denials and appeals are handled, but when claims are eventually processed successfully, clinics will need to refund any payments to the patient, less copays.

Definition of non-acute hearing issues: The CMS provided an example of non-acute hearing issues (i.e., gradually progressing hearing loss, usually in both ears). This limited direct access provision does not apply to vertigo, vestibular, or balance disorders, nor does it apply to other acute hearing or otologic issues. These patients should have a physician order as their signs and symptoms are not considered non-acute in nature. However, clinicians may also be unsure of whether the signs and symptoms of hearing loss among their patients would meet the criteria of being "non-acute." CMS has been contacted to request additional clarification and that information is forthcoming. As of current, if audiologists are uncertain about whether signs and symptoms would be "non-acute," they may consider using an Advance Beneficiary Notification (ABN) and appending the GA modifier to indicate that a mandatory ABN was administered. Clinicians are also reminded that documentation should illustrate the non-acute nature of the hearing issue in their clinical reports.

Conclusion

The Texas Academy of Audiology is working closely with the American Academy of Audiology to request information from the CMS regarding this new audiology limited direct access provision. TAA Members are encouraged to submit questions and comments to professionalissues@texasaudiology.org.
