## AMPLIFYING AUDIOLOGY: MAKING OUR VOICES HEARD AT THE TEXAS CAPITOL!

On March 12, 2025, we have a group of 40 audiology advocates registered, so far, to attend advocacy day at our state capitol in Austin. Our goal is to meet with elected officials and use our audiology voice to talk about the future of our profession.

Your Texas Academy of Audiology will be represented by 16 students (15 AuD students and 1 undergraduate student from Lamar University, the University of Texas at Austin, and from the University of Texas at Dallas), 1 audiology assistant, and 23 professionals coming from the DFW, Houston, and Austin metro areas.

Because the Texas legislature is only in session for 6 months once every two years, it is critical for us to utilize this opportunity to put a spotlight on audiology. This will be our fourth in-person advocacy trip since 2017 and this is the largest group thus far.

As a group, we will have the opportunity to meet with the TAA lobbyist Brad Shields, meetings with elected officials throughout the day, and the students will be able to meet with Erica Rodriguez at the Texas Department of Licensing and Regulation.

There are several bills up for consideration this year on topics including insurance coverage relating to cochlear implants and hearing aids, language amendments relating to the licensing and regulation of speech-language pathologists and audiologists, and the audiology interstate compact.

The current 89th Texas Legislature is in session through June 2, 2025. Please use this link to determine your state representative and state senator. Take 3 minutes to call/write to them to let them know you are an audiologist in their district and ask for their support! ## Breaking Barriers: Training the Next Generation of Bilingual Audiologists

An interview with Julia Campbell, PhD, AuD, CCC-A and Arianna M. Garcia, AuD, CCC-A

#### 1. Please tell me about the Bilingual Training Program in Audiology at the University of Texas at Austin Doctor of Audiology Program

#### Dr. Campbell:

The Bilingual Training Program in Audiology provides a one-year focus in audiologic care to the Spanish-speaking population. UT Austin is currently the only Audiology program in the US offering a badge for bilingual training in Audiology. Second-year student clinical experience will include a rotation through the University of Texas Speech and Hearing Clinic and will consist of one-on-one mentorship and training with a qualified Spanish speaking clinician. Students are required to complete a minimum of 20 clinical hours in one year with Spanishspeaking patients, as well as a course in the use of Spanish in the health field (offered at UT Austin). Finally, students will translate a clinical document into Spanish and complete a research or community project focused on audiologic care in the Spanish speaking population. At the completion of these experiences, the student receives a digital badge from the college with a link to their accomplishments, which may be included on their CV/resume.

## 2. What inspired you to offer this program?

#### Dr. Campbell:

Our clinic sees an overwhelming majority of Spanish-speakers, which is also a major population in the state of Texas. Many of our students speak Spanish but require extra training in applying this skill to audiologic care. Clearly, this is a major need in audiology as a field, so we wanted to take the first steps to fill this hole and better serve our patients.

#### Dr. Garcia:

I agree, having well trained professionals is vital to providing great patient centered care to this Spanish-speaking population we serve at the UTSHC. On a more personal note- I grew up in a Spanish speaking family and know what it's like to be the child translating for your parents during an appointment or some interaction. This program is a step towards removing that barrier for our patients and allows the students to create a trusting professional relationship with the patient because we are communicating in their language.

## 3. How does this program benefit students who participate?

#### Dr. Campbell:

I already slightly answered this, but they receive a digital badge to put on their resume and to show potential employers of this desirable skillset. They also have an opportunity to engage deeply with the Spanish-speaking population and serve through their translation of clinical documents and research or community outreach project. Hopefully, it encourages them to continue in this vein and support Spanish-speaking patients throughout their career.

The foundation is looking forward to seeing each of you in Denton this fall for fun, fellowship and education as TAA celebrates their silver anniversary.








## Expanding Access, Strengthening Advocacy: Your Voice Matters in 2025!

The 89th legislative session kicked off January 14, 2025. SB 905 was filed by Senator Judith Zaffirinni on January 24, 2025. SB 905 amends language Section 401.2021 relating to the **licensing and regulation of speech-language pathologists and audiologists.** Our TAA president Alex Morris, AuD, a representative from TDLR ,and TAA lobbyist Brad Shields met with Senator Judith Zaffirinni's office February 6th and were successful in providing recommendations to update the language of the bill for pediatric medical clearance to say "a licensed physician."

Currently, we need support from our membership for HB3090 filed February 20, 2025. "The bill amends Section 1367.253(a) of the Insurance Code to require health benefit plans to provide coverage for the cost of medically necessary hearing aids and cochlear implants for individuals who are 25 years of age or younger, replacing the previous age limit of 18 years. This change aims to expand access to essential hearing devices for a broader range of young individuals who may require them for medical reasons."

Lastly, waiting on a response from a Senator for the DFW area to file an ASPL-IC bill. "The ASLP-IC is an interstate compact designed to allow licensed audiologists and speech-language pathologists to practice across state boundaries and through telepractice both legally and ethically without necessitating that an individual become licensed in every state to practice." Michelle Moore, the government relations manager for the American Academy of Audiology, has been working with TAA to outline the key aspects of the compact and resolve any misconceptions.

Please check the TAA website for letter templates you can send to your state representatives. You just need to download and add your state congressperson's name and address and add your signature. TAA membership can significantly influence legislative issues that are important for our patients and our profession.
