## New Law

UPGRADE LAW TO BE IN EFFECT JANUARY 1, 2024

The 88th Legislative Session has been an active legislative season and the members of the board of the Texas Academy of Audiology have been hard at work! We have been busy tracking, supporting, and participating in furthering many legislative pieces that could affect audiologists this year. While the regular legislative session is over, the board's work is not! We will continue to monitor legislation that will affect audiologists in Texas as the Special Session(s) convene throughout the remainder of this legislative year.

Of note, one important bill that passed this legislative session is House Bill 109. House Bill 109 prohibits health benefit plans (that provide coverage for hearing aids) for denying an enrollee's claim for a hearing aid solely based on the price of the hearing aid.

Do you have patients that would like to utilize their hearing aid benefit for premium technology but can't due to their benefit amount? As of September 1, 2023, they will be able to! House Bill 109 stipulates that a health benefit plan would not be required to pay an enrollee's claim for a hearing aid that costs more than the benefit available under the health benefit plan, however, the enrollee or other entities may make up the difference between allowable benefit and actual cost.

What this means is that if you have a patient with a \$1,000.00 in-network benefit, they may now pay the difference to upgrade to a hearing aid that costs more than their \$1,000.00 benefit amount. While the bill is scheduled to take effect on September 1, 2023, it will only apply to health benefit plans delivered, issued for delivery, or renewed on or after January 1, 2024.

### TAA 24th Annual Conference in San Marcos



Annual Meeting. Our poster session will feature posters highlighting either clinical cases or novel research projects from students of the Texas AuD programs or externs at Texas facilities.
Submissions are open only to student members of TAA. Student must be available on Friday, October 13 for poster presentation at the conference, times to be determined.

Presentations should document research projects (including novel research, results from pilot studies, or systematic literature reviews) or clinical cases in the areas of hearing or balance science.

#### **Submission Guidelines**

Research submissions must include the (1) title of poster, (2) names of all authors, (3) abstract of 75 words, and (4) multiple choice question for audience about the research

Clinical case study submissions must included (1) title of the case study, (2) name of the presenter, (3) summary of the case (75 words or less), and (4) multiple choice question for audience about the case

Submissions must include the contact information (email; phone number; university/externship facility affiliation; and physical address) of the primary author (i.e., the entrant). Questions may be addressed to our student engagement liaison, Grace Kendrick
