The Champion Township Board of Trustees met for a public hearing on a Zoning Amendment on Paring Facilities and removing other sections from the Zoning Book on December 2, 2019 at 5:40pm. The Chairman called the meeting to order with a full board present.

The Fiscal Officer showed proof of publication.

The Chairman swore in John Streitferdt, the only community member present, who wished to speak not for or against, but as a Zoning Commissioner.

Chairman Fee called for Opponents to the Zone Change.

Mr. Streitferdt described a minor text change, where the word "length" had been left out of the original Parking Facilities information given to the board.

The Board understood the minor text change and thought it was acceptable.

Trustee Emerine questioned if this change is just for new construction or for any resurfacing of old lots.

Trustee Bugos asked how many businesses were currently in compliance with the standards for parking. The Zoning Commissioner stated that they found many businesses all over the place, from as narrow as 7' to as short as 15'.

Trustee Fee interjected that he did not want to have to put an undue burden on businesses to pay for a permit.

Trustee Emerine stated that he did not see anything in our zoning that even required them to stripe their lots in the first place. He stated he was afraid that businesses would just not bother to stripe their parking lots if they were required to pay a fee. Trustee Fee remarked that this could be an undue hardship on something that a business was required to do pretty regularly when up keeping their property. Much concern was expressed on the small business population within the Township that would have an extra fee.

Mr. Streitferdt stated that the Zoning Commission did not care about the permit price per se, they just wanted to see compliance with standards and the new recommendation was the current County regulations. The Board addressed Zoning Inspector Fonce with a question about fining businesses not in compliance but making the permit free. Zoning Inspector Fonce stated that the only authority the Board had was to double the fine, so if the fee was zero, there would be no consequence.

Trustee Bugos discussed that he had experience in this business and he has seen the mess left behind if someone were to have to change their lines and the prior resurfacing job had been "cut" too thinly.

Trustee Fee made mention of an issue with the new school being out of compliance and that they were not made to fix their stripes.

Chairman Fee called twice more for Opponents and Proponents.

Zoning Inspector Fonce asked the Board to accept or deny the change.

Trustee Bugos made a motion for the Board denied the Zoning Change due to requesting that the Zoning Commission make more distinct recommendations on which business activities would need a permit (every time or just on new construction), a lower cost fee or an idea of how to bring the current violators in to process. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

Commissioner Streitferdt said that he would relay the message to the Zoning Commission.

Hearing no further comment, the Chairman adjourned the meeting.

G2019-100 Trustee Emerine made a motion to approve at the request of Fiscal Officer Hatt the appointment per statute of Vanessa Teuscher, 4692 Hummel Drive NW, Warren, Ohio, to the position of Assistant to the Fiscal Officer, at a rate of \$10.00/hour, not to exceed a maximum of 500 hours per year. Appointment is retroactive to start date of September 16, 2019. Trustee Fee seconded. Bugos yes, Emerine yes, Fee yes. Trustee Bugos interjected that he felt there were other more qualified applicants for the position who were not given this opportunity. Trustee Fee reminded those present that statute allows Fiscal Officer Hatt to choose whomever she would like to assist her, as verified by his call to the township legal counsel.

Trustee Bugos made a motion to accept the donation of Vesey's Carpet Care, approximately \$150 value, for cleaning the chapel carpets. This service was requested as part of the 2019 Division of Commerce Real Estate and Professional Licensing Cemetery Grant recently awarded in the amount of \$5,000.00. This donation will allow the Township to tackle other projects with the grant dollars. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

R2019-101 Trustee Bugos made a motion (see full text attached) at the request of OPWC to grant Trustee Doug Emerine power to act as applicant and Chief Executive Officer on the 2020 Bridge Rehabilitation and Resurfacing Project, Michael Rozzo as Project Manager and Fiscal Officer Hatt, by default the Chief Financial Officer. Trustee Emerine accepts this appointment. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

R2019-102 Trustee Bugos made a motion to encumber the 2020 Bridge Rehabilitation and Resurfacing Project the Township share of \$68,823, a 24.8% share, partially of in-kind services. The County share will be 21.2%, with our share of OPWC grant dollars being \$73,921.00, to be placed per OPWC rules in a new fund for that sole purpose. Trustee Emerine seconded. Bugos yes, Emerine yes, Fee yes.

Trustee Emerine made a motion to accept the 2019 Scrap Tire Grant Disbursement, in the amount of \$2,072.10 from Geauga Trumbull Solid Waste District. Trustee Bugos seconded. Bugos yes, Emerine yes, Fee yes.

Road Supervisor Rozzo gave the storage facility inventory. He plans to get a dumpster and remove several items from the inventory as worthless when there is time for the Road Department to get to that project.

The Fiscal Officer presented correspondence.

The Park Land Use Proposals were considered. Public comment was mildly interjected at this time. The Trustees went back and forth on budgetary and community needs in this matter.

Trustee Bugos made a motion to appropriate up to \$10,000.00 from the Park fund to move forward with an update to the Comprehensive Plan to be completed by the GPD Group. The motion failed for lack of second.

New Business

The December Year End meeting was set for December 18, 2019 at 3:30 pm. Chairman Fee gave an update on the Research Parkway situation with the County engineer's office. Chief Hickey presented information on the Squad 21 accident. Deductible is \$2,500 and repairs were estimated at \$1,671.

Public Comment

Debbie Christ, 400 Lauder, had comments about the park, thanking Rex for his 4 years of service and thanking the Board for including the public/Trustee Elect Templeton on the park discussion. Holly Capron, 408 Atwood, had comments about a drug/whorehouse in her neighborhood. Trustee Fee asked for the location. She let him know she had reported it numerous times and was going to burn the place down if the drama continues. The Police Chief stated that they were aware of the ongoing problem.

Tami Hoostal, 4901 Brookside, called ODOT for an update on the Noise Wall and is awaiting a call back.
